The humble petition on behalf of the above named petitioner;

Most respectfully sheweth :-

1. That on 22/12/2016 in morning the petitioner went to his land bearing Plot No. 519 where he used to grow bird and other seeds.
2. That at about 9 - 9.30 A.M. Birbal Mandal entered into the land and told the petitioner to go home and they will cut the ^{Trees} seeds. The petitioner made protest but Birbal called his two brothers namely Subhas Mandal and Kashinath Mandal. They came and their father Robilochan Mandal and Bapi Mandal S/o Kashinath Mandal also came and entered into the land of the petitioner.
3. That under direction of Robilochan Mandal all other accused persons assaulted the petitioner with back side of spade in chest. and with Bhojali in his left palm. The petitioner became senseless and fell down over the land.
4. That the accused persons cut six palash trees and took them. They left the place. While they saw that the sons were coming towards the field. Prahallad Chandra Mandal Trilochan Mandal and one Bihir Mandal took the petitioner to Hura B.P.H.C. for treatment. Hura B.P.H.C. referred the petitioner to Deben Mahato Sadar Hospital at Puculia.
5. That the petitioner was discharged from hospital and thereafter went to Hura Police Station to lodge a

Lastly when your petitioner saw that the police did not register any case, the petitioner made complaint to the Superintendent of Police at Purulia with a hope that they will take step but till date no action was taken. Hence delayed.

6. That your petitioner is aged about 73 years old, Person and the case requires investigation by police.

It is, therefore, prayed that your Honour may be graciously pleased to direct the police of Hura Police Station to treat this petition of complaint as an F.I.R. under the provision of 156(3) of the Criminal Procedure Code and to cause investigation in respect of the alleged incident.
