With due respect I do hereby lodge a written complaint against 1. Bibek Ranga, Dist Secretary of BJP Dist-Purulia, 2. Vidyasagar Chakraborty Dist President of BJP Dist-Purulia 3. Abdul Alim Ansary Dist President of BJP Dist-Purulia 4. Falguni Chatterje of Ladhurka PS- Hura Dist-Purulia 5. Bimal Singh Sardar of Keshargar PS- Hura Dist-Purulia 6. Bhim Bouri of Keshargar PS- Hura Dist-Purulia and five others of BJP supporters to the effect that on 12/06/2020 in course of mobile duty at about 12:30 hrs I received an information from my reliable source that some supporters of B.J.P under the leadership of Bibek Ranga of Dist Secretary of BJP Purulia District entered into the quarantine centre of Keshargarh High school to show political activities. As such myself along with force reached there. On seeing Police van they all managed to escape from there. I could learn that VP Upen Mahato and CVF Madan Kaibarta who were engaged on watch-duty at Keshargarh High school opposed them and directed not to do any political programme but they did not care.

After that they also entered into the another quarantine centre at Jabarra High school at 13:25 hrs and also created the same scene. There also V.P Susanta Mahato & CVF Ganesh Garai who were engaged on watch duty at Jabarra High School premises opposed and directed them not to do any political programme but to no effect.

On Local enquiry revealed that the above noted persons attached to BJP entered into both the quarantine centres without obtaining authentic permission for political gain which created panic among the quarantined persons.

As per Govt. circular, the political programs irrespective of all political parties are restricted in this pandemic situation.

Moreover The above persons created panic amongst the quarantined persons by circulating false data and thus tried to make them believe the situation as very much disasterous and not controllable that way.

Such spread of rumour by them created panic among the QP and it was likely to give rise of provocation to create LO Problem.

The political persons also disobeyed the Government Order to combat spread of Corona virus throughout the India as well as whole World.

I, therefore, lodge complaint against accd. persons namely 1. Bibek Ranga of Dist Secretary of BJP Dist-Purulia, 2. Vidyasagar Chakraborty Dist President of BJP Dist-Purulia 3. Abdul Alim Ansary Dist President of BJP Dist-Purulia 4. Falguni Chatterje of Ladhurka PS- Hura Dist-Purulia 5. Bimal Singh Sardar of Keshargar PS-Hura Dist-Purulia 6. Bhim Bouri of Keshargar PS- Hura Dist-Purulia and five others of BJP supporters and pray for start of a case under specific section of law.
