With due respect I do hereby lodge a written complaint against the arrested accd persons namely (1) Sunil Sabar (26) S/O Rabi Sabar, of Vill- Chirugora, PS- Boro, Dist.- Purulia (2) Krittibas Sabar (22) S/o Bhim Sabar, Vill- Gholkuri, PS- Ranibandh, Dist.- Bankura (3) Nirmal Ch. Majhi (25) S/O- Sadananda Majhi, Vill- Gholkuri, PS- Ranibandh, Dist.- Bankura (4) Rabi Paramanik (25) S/O- Sahebram Paramanik, Vill- Simla-majra, PS- Kashipur, Dist.- Purulia (5) Uttam Kr. Hansda (22) S/O- Santa Hansda, Vill- Simla-majra, PS- Kashipur, Dist.- Purulia (6) Tapas Karmakar (21) S/O- Krishnapada Karmakar Vill- Simla-majra, PS- Kashipur, Dist.- Purulia to the effect that on 20.06.2020 at about 17.05 hrs while I SI Partha Sarathi Shit along with force were performing day mobile duty vide Hura PS GDE No- 753 Dated- 20.06.2020 and CC No 1788/20 dtd. 20.06.20 and found the above noted persons along with 02 (two) Motor Cycles bearing registration no. WB 82A/5891 & another Motor Cycle does not have Registration Number, bearing Eng. No. HA10AGKHAA6981 and Chassis No. MBLHAR083KHA67712 were roaming aimlessly at Lalpur more area. We detained them at Lalpur more on NH60A (Bankura - Purulia pitch road) under Hura PS. On being asked the above accused persons could not able to give any satisfactory answer for that movement on road and public place. Though lockdown is going on throughout the District of Purulia in view of Pandemic of COVID-19 outbreak vide Govt. of India consolidated order No-40-3/2020-DM-1 (A) Date-24/03/2020 and further modified dated-25/03/2020, 27/03/2020, 02/04/2020, 03/04/2020, 10/04/2020 and 02/05/2020 for restriction measure. As such the above persons violated the order during this pandemic situation duly promulgated by Govt. of West Bengal vide Order No- H & F W/120/20 dated 22.03.2020. Moreover all the detained persons refused to comply the direction given by the Central Govt. & State Govt. to combat the severity of COVID-19 pandemic. All the accused persons also tried negligently to spare infection of disease dangerous to life. So I arrested them and seized 02(two) Motor Cycles bearing registration no. WB 82A/5891 & another Motor Cycle does not have Registration Number, bearing Eng. No. HA10AGKHAA6981 and Chassis No. MBLHAR083KHA67712 with proper seizure list duly signed by the witnesses.


