Petitioner Most respectfully beg to state as follows :-

- 1) That the petitioner/ complainant and the accused persons are the residents of the village under Jhajda Police Station within Purnia District which is under your jurisdiction.
- 2) That the accused persons were well-acquainted with the complainant and both of them used to maintain a good and courteous relation between them before some days.
- 3) That the accused persons, being the law owner of the scheduled land mentioned below proposed your petitioner/ the complainant to purchase 10 decimals of their lawfully owned land in exchange of Rs. 50,000/- as the market rate of that land and they also informed the complainant to give them such amount on an agreement to be executed by them as land lord as they were in very urgent need of such amount.
- 4) That the complainant was also looking for such land for his persons use and agreed to purchase the proposed land measuring an area of 10 decimals.
