beg to inform you that my daughter namely
Nafisha Bibi aged about 20 years got married
in the year 01-06-2012 with Kamal Ansari @ Disco
s/o Safik Ansari of village Kuki, P.S. - Thalda,
Distt - Purulia, having maintained Muslim Customs.
But since after marriage the inlaws members
namely her husband Kamal Ansari, father inlaws
Safik Ansari, mother inlaws Ful Batan Bibi and
first wife Jarina Bibi ^{brother Makim Ansari}, all of the same village
used to tortured her both physically and
mentally. My daughter informed us regarding
this torture. Today we have been informed
by son inlaw Kamal Ansari that her wife
committed suicide ~~he~~ herself by drowning
into a well. After reaching at Kuki village we
saw the deadbody of her daughter which was
lying on a cot. I think this is not suicide
rather all the above inlaws members killed her
having preplanned and thrown the body in the well
which is located about 20mts away from inlaws
house. So I request you to Lodge FIR in respect
of this facts and start investigation for Justice.
