In Producing here with one arrested accd. Person namely Biren Chandra Saw Aged 43 Yrs. S/O Khirod Prasad Saw of Vill. Dumuridih, P.S. Jhalda, Dist. Purulia brought under arrest with seized article 01(One) white coloured plastic jar cane containing approx 04 (Four) Ltrs of I.D. Liquor and 12 (Twelve) full bottle of Dilkhush @ 600 Ml. Each of country spirit from his possession. I do hereby lodged this written complain to the effect that on-06/03/2017 at about 19:05 hours during my Anti Crime Patrolling Duty I received telephonic source information that one person Saleing illegal I.D. Liquor and Country sprit at Dumurdih Village more in lieu of Money. I inform the matter to I/C Jhalda P.S over Phone as per his direction myself along with ASI Manas Kr. Panda, C/1471 Sankar Ruidas, C/380 Ajoy Krishna Roy left for Dumuridih village to work out the information. We reached at Dumuridih Village at about 19:45 Hours and keep our vehicle on the Road. We proceeded on foot through the Gola Road near the shop of accused at Village Dumuridih as shown by our source. After reached at the said shop we found one person is saleing I.D liquor and country spirit in front of the shop of the above noted person and some persons were gathered in front of him. Seeing police party they started to flew away after a small chase we are manage to detain one person, on being asked he disclosed his identity as noted above. On search we found 01(One) white plastic Jar cane containing approx 04(Four) Ltrs of I.D. Liquor and 12 (Twelve) full bottle of Dilkhush @ 600 Ml. Of country spirit Each and Rs.440/- Sale proceed from his shop. On Interrogation he stated that he use to sale the LD. Liquor and country spirit in lieu of Money for his illegal gain. On demand he also failed to produce any valid challan / Papers in respect of I.D. Liquor and country spirit. Hence he violated the provision of 46 (A) (c) of B.E. Act.

Accordingly I arrested accd. Biren Chandra Saw Aged 43 Yrs. S/O Khirod Prasad Saw of Vill. Dumuridih, P.S. Jhalda, Dist. Purulia and prepared arrest memo and seized the 01(One) white plastic lar cane containing approx 04(Four) Ltrs of l.D. Liquor and 12 (Twelve) full bottle of Dilkhush @ 600 Ml. Of country spirit Each and Rs.440/- Sale proceed from the possession of Biren Chandra Saw Aged 43 Yrs. S/O Khirod Prasad Saw of Vill. Dumuridih, P.S. Jhalda, Dist. Purulia after preparing proper seizure list duly signed by the accd. Person and witnesses and prepared proper label for seized articles duly signed by the accd. Person and witnesses. I search

for local witnesses but found none.

I return to P.S. along with accd, person and all seized articles. Put the accd. Person in the Lock UP after maintaining all formalities and submitted this written complain before you to started a case against Biren Chandra Saw Aged 43 Yrs. S/O Khirod Prasad Saw of Vill. Dumuridih, P.S. Jhalda, Dist. Purulia under proper section of law.
