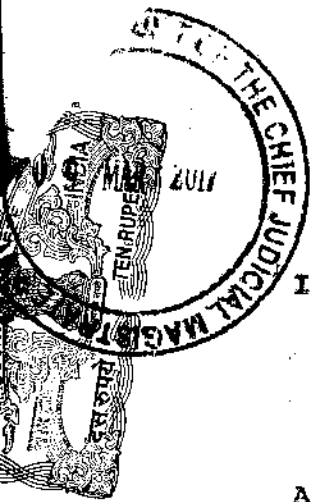

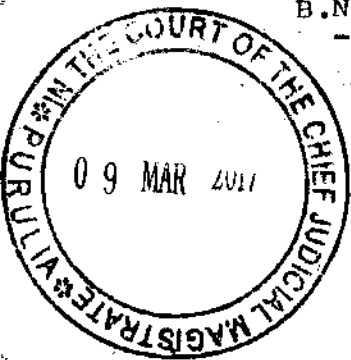

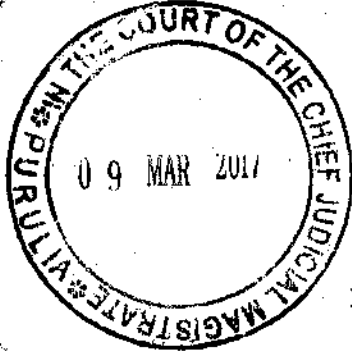

E. Offences:-

U/s 147, 447, 427, 379 I.P.C.

The above-named complainant begs to state as follows:-



1.---That the schedule ^{property} was previously belonged to Binod Ghasi of village Ichag, P.S.Jhalda, District Purulia. Said Binod Ghasi was the recorded owner of the schedule property. Said Binod Ghasi ^{possessed} ~~purchased~~ the schedule land till his death, Bindo Ghasi died leaving behind his three sons namely Hare Krishna, Gudu and Labin Ghasi as his only legal heirs. After the death of Bindo Ghasi aforesaid Hare Krishna, Gudu and Labin Ghasi inherited the schedule land and came into actual physical possession of the schedule land.

2.---That while the aforesaid Harekrishna, Gudu and Labin Ghasi, were in physical possession of the schedule land, they sold away the schedule 1 property by executing and registering a Sale deed to the present complainant on consideration of Rs.12,293/- and gave delivery of possession to the present complainant on 05-01-2009.

3.---That after purchase present complainant came into actual physical possession and ^{planted some} trees upon the schedule land and grew up the said trees.

4.---That on 21-02-2017 at about 6.00 a.m. present accused persons No. 1 to 5 making an unlawful assembly with greivous weapon such ^{as} Axe, Tangi, Lathi etc. most illegally and forcibly criminally trespassed the schedule land and started to cut the aforesaid Sajna trees. The said ~~xxx~~ Sajna tree was full of suties. The complainant and the witnesses No.2 to 4 ^{requested them} not to cut the aforesaid trees .But the complainant threatened to kill the complainant and her family members. So the complainant rendered helpless. The accused persons No.1 to 5 cut and ~~xx~~ removed ^{the} ~~from~~ tree and ^{took away} ~~all~~ Sanja Suties from the place of occurrence to their house. Complainant sustained loss of Rs.10,000/- (Ten thousand). There after complainant informed the aforesaid incident to the local police at Jhalda, P.S. But the police of Jhalda P.S. has not taken any steps. There after present complainant informed the aforesaid incident to the Superintendent of police, Purulia. Inspite of the police of Jhalda police is quite mum and has taken no action. So the complainant is bound to file this case for proper relief.

It is, therefore prayed that your honour may graciously be pleased to sent the complt. to ~~xxx~~ Jhalda P.S. treating this complaint as F.I.R.U/s 156(3) Cr.P.C.
