In producing herewith one arrested accd. Persons namely (1) Pasupati Kandu (71Yrs.) S/O Lt Lurku Kandu of Jhalda Ojha Para, Ward No. 3, P.S. Jhalda Dist.- Purulia and (2) Pandab Mahato (62Yrs.) S/O Khedan Mahato of Village – Darda, P.S. Jhalda, Dist. Purulia brought under arrest with seized articles (i) 25 sealed bottles of country spirit (DIL KHUSH 80<sup>0</sup> U.P.) containing 600 ml each. (ii) 30 sealed bottles of country spirit (RAMBO 80<sup>0</sup> U.P.) containing 600 ml each.

I do hereby lodged this written complaint to the effect that on-12/3/17 at about 19:00 hrs I and along with officers and force performing Anti Crime Mobile duty at Jhalda Ojhapara near Roy Video Hall under Jhalda Town area, PS- Jhalda, dist- Purulia and found that the above noted arrested persons were jointly keeping and selling Country spirit illegally in view of income money. On demand they failed to produce any valid documents in respect of these keeping and selling of said C.S. So I arrest them and on searching I seized the (i) 25 sealed bottles of country spirit (DIL KHUSH 80° U.P.) containing 600 ml each. (ii) 30 sealed bottles of country spirit (RAMBO 80° U.P.) containing 600 ml each under proper seizure list. I interrogated them. On interrogation they admitted that they were keeping & selling C.S jointly in view to earn mony. During interrogation it strongly reason to believe that they violated the provision of 46 (Λ) (c) of B.E. Act. The arrest and seizure was made from 19.35 hsr to 20.15 hrs. with maintaining all formalities of arrest duly signed by the witnesses accd. persons.

I return to P.S. along with accused person and all seized articles. Put the accused. Persons in the P.S. lock up after maintaining all formalities and submitted this written complaint before you to started a case against (1) Pasupati Kandu (71Yrs.) S/O Lt Lurku Kandu of Jhalda Ojha Para, Ward No. 3, P.S. Jhalda Dist.- Purulia and (2) Pandab Mahato (62Yrs.) S/O Khedan Mahato of Village – Darda, P.S. Jhalda, Dist. Purulia under proper section of law.
