Sir,

In producing herewith one arrested accd. Person namely Dhiren Karmali (45 yrs) S/O Niranjan Karmali of Vill- Badgram, PS- Jhalda, Dist - Purulia, brought under arrest with seized articles i) One white colour plastic jerkin containing approx 10 (ten) ltrs I.D. Liquor ii) one Aluminium Handy (medium size) iii) One blue colour old bonospati jarikan containing approx 10 kg. Molasses iv) Some fire wood. I do hereby lodged this written complaint to the effect that on-25/03/2017 at about 19:05 hours when I and along with officer & force performing evening duty at Mahatomara side, on getting a credible source information that one person was making I.D liquor at Near Badgram village river side. After that I informed I/C Jhalda PS and as per direction of him we rushed to the spot to work out the information. Keeping our vehicle in a safe distance we went to the spot on foot, seeing police party he started to fled away after a small chase we were able to detain this person who on asking disclosed his identity as noted above and also found that he was making I.D Liquor by distillery system from MAHUA. On search we found i) One white colour plastic jerkin containing approx 10 (ten) ltrs I.D. Liquor ii) one Aluminium Handy (medium size) iii) One blue colour old bonospati jarikan containing approx 10 kg. molases iv) Some fire wood. On Interrogation he stated that he use to product the said I.D liquor for his illegal gain. On demand he also failed to produce any valid licence for production of I.D liquor. Hence he violated the provision of 46A (a) (b) of B.E. Act.

Accordingly I arrested accd. namely Dhiren Karmali (45 yrs) S/O Niranjan Karmali of Vill- Badgram, PS- Jhalda, Dist - Purulia and prepared arrest memo and I also seized the following articles i) One white colour plastic jerkin containing approx 10 (ten) Ltrs I.D. Liquor ii) one Aluminium Handy (medium size) iii) One blue colour old bonospati jarikan containing approx 10 kg. molases iv) Some fire wood from the P.O. after preparing proper seizure list duly signed by the accd. Person and witnesses. And prepared proper label for all seized articles duly signed by the accd. Person and witnesses. I also destroyed the production material i.e weight mahua, and others (pachai) three jariken. I search for local public witnesses but found none.

I return to P.S. along with accd person and all seized articles. Put the accd. person in the Lock UP after maintaining all formalities and submitted this written complaint before you to start a case against Dhiren Karmali (45 yrs) S/O Niranjan Karmali of Vill- Badgram, PS- Jhalda, Dist - Purulia under proper section of law.
