Sir,

I, SI Sahadeb Jana (59) S/O Lt. Shyam Charan Jana now attached to Jhalda Police Station do hereby lodge a written complaint against approx 120 unknown miscreants to the effect that on 11/04/17 at about 17:30 hrs. A procession was taken out from Satybhama high school, on the occasion of Hanuman Jayanti at Jhalda Proper. Around 15/20 thousand people participated in this procession. At about 17:45 hrs. while the procession reached at Bagandih suddenly some unknown miscreants pelted stones indiscriminately when the whole procession almost crossed peacefully resulting some injuries of some processionist and Police who were performing Law & Order duty and providing security to the peace loving processionist and common people on road.

Subsequently, a part of the crowd / Mob at that spot became riotous. Seeing that, I commanded that to immediately disperse from the spot to maintain peace and tranquility. However the unruly mob did not relent and started behaving as unlawful assembly. Some unknown unruly persons set fire upon two shops which could be controlled quickly by the fire tender service and doused the same due to quick response of the Police team. Later it was found that 2/3 shops were also damaged to some extent. However the remaining procession ended peacefully due to full coverage by Police team deployed for law and order duty there. Immediate arrest could not be made as the miscreants could not be identified. The injured persons and Police later attended Jhalda BPHC for their medical treatment.

I, therefore requested you to record a specific case against approx 120 nos. unknown miscreants for unlawfully assembling, injuring people, including Police, setting custody of property on fire and damaging some shops with criminal intent and intimidation, rioting and to cause for its investigation.
