Sir,

In producing here with the arrested accused person Rambilas Tantubay (24 years/ Male), S/O- Lalchand Tantubay of village- Kumardih, P.S- Arsha, Dist- Purulia and brought under seizure the following articles total 40 (Forty) bottles of PHENCYREX syrup, 100ml each (Chlorpheniramine Maleate & Codeine Phosphate Syrup) of M.B company, Batch No-06026-SMB1 from one black coloured school bag from the possession of the accused person. After preparing proper seizure list duly signed by the witnesses as well as accused person. I do here by lodged a written complaint against the above noted accused person to the effect that on today (04/05/17) at 16:05 hrs received a telephonic information from my source that one person is coming from Birsha More to Jhalda Bus stand side with huge quantities of drugs with him. After received such type of information, I informed I/C Jhalda as per his direction myself along with force who were performing special evening mobile duty being accompanied SI. S Roy and his team rushed to Birsha More and keep our vehicle at Hat-tola. We wait at Birsha more for few minutes and at 16:35 hrs we found one person coming from Baghmundi side and going towards Jhalda Bus stand. We intercepted him at Birsha More, word No- 2, Jhalda Municipality and on being asked he disclosed his identity as noted above. On being searched we found the accd person was caring black coloured school bag loaded with 40 (Forty) bottles PHENCYREX syrup (illegal drug). On interrogation he also disclosed that he procured all those from the owner namely Dilip Keshri S/O Lt. Kishnalal Keshri Ward No - 6, Kumarkuli, P.S. Jhalda, Dist- Purulia of Radhika Medical. On demand he failed to produce any valid documents/ licence in respect of keeping the said drugs. So I seized the same under proper seizure list duly signed by the witnesses as well as the apprehended person. I arrested the accused person for violating the sec. 27 of drugs & cosmetics Act 1940.

I therefore pray before you to start a case against the accused persons- (1) Rambilas Tantubay (24 years/ Male), S/O- Lalchand Tantubay of village- Kumardih, P.S- Arsha, Dist- Purulia, (2) Dilip Keshri S/O- Lt. Kishnalal Keshri Ward No - 6, Kumarkuli, P.S. Jhalda, Dist- Purulia under sec. 27 of drugs & cosmetics Act 1940 and arranged for its investigation.
