Sir,

In producing here with arrested accused namely Suresh Bauri (33), S/o-Srishtidhar Bauri, of Vill-Mukundapur, PS-Joypur, Dist-Purulia, under arrest along with seized articles as per seizer list i.e. (1) 25 Pices Dil Khush country sprit in plastic bottle 375 ML in each bottle (2) 05 Paces Dil Khush, country sprit in plastic bottle 600 ML in each bottle (3) 02 empty plastic glass, under proper seizure with label. I ASI Susanta Ghosh .of Joypur PS hereby lodged a written complaint against the above noted accused person to the effect that today (06/03/17) myself along with C/-581 Tanmoy Chaterjee C/-179 Balaram Mandal all of Joypur PS, where holding raid against illicit manufacturing / selling of liquor at PS area. In course of raid I received a secret source information at about 17.45 hrs that the above noted persons namely Suresh Bauri (33) S/o-Srishtidhar Bauri, of Vill-Mukundapur, PS-Joypur, Dist-Purulia, selling of ID liquor illegally without having any licence / authority at his grocery shop at Mukundapur village. After receiving such information I informed to IC Joypur PS over cell phone and as per his instruction myself along with force had been to Mukundapur village the grocery shop of Suresh Bauri at 18.05 hrs and found that the said person was illegally selling the Id liquor to the customers, but Seeing the Police party all the customers where managed to escape. On being asked produce to any valid documents in respect of stock and selling the ID liquor, but he failed to produce any valid documents in support of stock & selling ID liquor. Accordingly I seized the above noted articles from the possession of the accused and label, duly singed by the accused person & witnesses and properly sealed and label in between 18.25 hrs to 18.55 hrs in which one each bottle of ID liquor i.e. one 375 ML and one 600 ML were kept as sample file with label. During interrogation he confessed his guilt I arrested him after observing all the formalities issuing memo of arrest as the accused person is liable for prosecution u/s-46A (c) of the Bengal Excise Act 1909.

I therefore pray that a specific Case may kindly be started against the accused person namely Suresh Bauri (33) S/o-Srishtidhar Bauri, of Vill-Mukundapur, PS-Joypur, Dist-Purulia, u/s-46A (c) of the Bengal Excise Act 1909
