Sir,

In producing herewith one arrested accused person namely Bhiguram Kumar (28) S/o-Dhiren Kuma, of Vill-Bhatdih, PS-Joypur, Dist-Purulia, under arrest along with seized articles as per seizer list i.e. 27 (twenty seven) plastic bottles country sprit printed as "Dil Khush" on the upper side of the bottles having 600 ML in each bottle in a plastic bag, under proper seizure with label.

I SI Jayanta Kr. Chakarborty of Joypur PS hereby lodged a written complaint against the above noted accused person to the effect that today (09/03/17) at about 11.15 hrs I received a credible source information that one person namely Bhiguram Kumar of Bhatdih village was proceeding towards Ranibandh side on foot carrying one plastic "THALI" in his hand containing ID liquor for the purpose of selling the same in Bhatdih village. On receipt such information I immediately diaries the matter at Joypur PS vide JoypurP.S GDE No- 426 Dated- 09/03/17 and informed the matter to IC of the PS and as per his direction I along with C/-102 Jogindar Singh, NVF- 0838 Sk Sadam Uddin & NVF 889 Binoy Ch. Mahato all of Joypur PS left to work out the information (This refers to Joypur PS CC No. 844 dated 09/03/17). At 11.40 hrs while we reached near to Rahardaga village more on Ranibandh - Bhatdih pitch road my source shown the person as per information. I immediately got down from our Govt. Vehicle and intercepted the above noted person and on search found the above noted seized articles in a plastic bag. On demand he failed to produce any license / authority of the said-liquor. On interrogation he also made incoherent statement regarding possession of said liquor and told that that he will sell the same in Bhatdih village upon the villagers illegally. So, finding no any other alternative way I seized the above noted articles from the possession of the accused and labeled, duly singed by the accused person & witnesses in between 11:45 hrs to 12:15 hrs in which one bottle of ID liquor i.e. one 600 ML was kept as sample file with label. During interrogation he confessed his guilt as such I arrested him after observing all the formalities as per law issuing memo of arrest as the accused person is liable for prosecution u/s-46A (c) of the Bengal Excise Act 1909.

I therefore pray that a specific Case may kindly be started against the accused person namely Bhiguram Kumar (28) S/o-Dhiren Kumar, of Vill-Bhatdih, PS-Joypur, Dist-Purulia u/s- 46A (c) of the Bengal Excise Act 1909
