In producing herewith arrested accused person namely (1) Astom Kumar (52) S/o Late Ghasiram Kumar and (2) Dactor @ Alok Kumar (24) S/o Astom Kumar, both of Vill-Taltol-Bhatdih, PS-Joypur, Dist-Purulia, under arrest along with seized articles as per seizer list i.e. 48 (Forty Eight) plastic bottles country sprit printed as "Dil Khush" on the upper side of the bottles having 600 ML in each bottle in a plastic bag and 87 (Eighty Seven) plastic bottles country sprit printed as "Dil Khush" on the upper side of the bottles having 375 ML in each bottle in an another plastic bag, i.e. total measuring (48 x 600) =28800 M.L. & (87 x 375)=32625 ML =Total 61425 ML i.e 61.425 Lts under proper seizure with label.

I SI Nirmal Kumar Pandey of Joypur PS hereby lodged a written complaint against the above noted accused persons to the effect that today (21/03/17) at about 16:25 hrs I received a credible source information that the above noted person Astom Kumar of Taltol under this PS conjointly with his son selling liquor in their Pan Stall at Taltol on Bhatdih More without any license.

On receipt such information I immediately diaries the matter at Joypur PS vide Joypur P.S GDE No-986 Dated-21/03/17 and informed the matter to IC of the PS and as per his direction I along with SI Jayanta Kumar Chakraborty, C/975 Ashok Saha Roy, C/699 Biswajit Banerjee & C/340 Baman das Goswami all of Joypur PS left to work out the information at 16:35 Hrs. (This refers to Joypur PS CC No. 997 dated 21/03/17). At 16:50 hrs while we reached at Taltol on Bhatdih More on Joypur-Bhatdih pitch road my source shown the said pan stall as per information. We immediately got down from our Govt. Vehicle and geherod the said pan stall. On the time some customers managed to flee away from the spot. But, we intercepted the above noted persons and started to search and on searching found the above noted seized articles kept concealed inside the "PAN GUMTHI" in two plastic bags. On demand they failed to produce any license / authority in respect of the said liquor about stock and selling. On interrogation they also made incoherent statement regarding possession of said liquor in their stall and told that they stocked the said for selling the same in their area upon the villager's illegally in regular basis. So, finding no any other alternative way I seized the above noted articles in "PAN GUMTHI" from the possession of the accused persons and labeled, duly singed by the accused persons & witnesses in between 17:05 hrs to 17:35 hrs in which one bottle each of liquor i.e. one 600 ML & another one 375 ML, both were kept as sample file with label. I tried my label best to sign the public witness in the seizure list, but none willing to put their signature on the seizure list. During interrogation they confessed their guilt as such I arrested them after observing all the formalities as per law issuing memo of arrest after narrating them the ground of arrest as the accused persons committed such type of offence, are liable for prosecution u/s-46A (c) of the Bengal Excise Act 1909.

I therefore pray that a specific Case may kindly be started against the accused persons namely (1) Astom Kumar (52) S/o Late Ghasiram Kumar and (2) Dactor @ Alok Kumar (24) S/o Astom Kumar, both of Vill-Taltol-Bhatdih, PS-Joypur, Dist-Purulia u/s-46A (c) of the Bengal Excise Act 1909
