Sir,

In producing herewith one arrested accused person namely Kalipada Mondal (32) S/o-Palton Mondal of Vill-Jahajpur, PS-Joypur, Dist-Purulia, under arrest along with seized articles as per seizer list i.e. 19 (Nineteen) liters Id Liquor (CHOLAI) in a Tube made by rubber and 01 (one) liter Id Liquor (CHOLAI) in a plastic bottle as sample file and one Honda Motor Cycle having registration No. WB56J/4830, under proper seizure with label.

I SI Jayanta Kr. Chakraborty of Joypur PS hereby lodged a written complaint against the above noted accused person to the effect that today (05/05/17) at about 14.45 hrs during my anticrime Naka checking duty at Kathaltard I received a credible source information that one person namely Kalipada Mondal of Vill-Jahajpur was proceeding towards Agharpur side by driving one Honda Motor Cycle having registration No-WB56J/4830 and carrying CHOLAI loaded in a tube for the purpose of selling the same in Agharpur-Ramamoti village side. On receipt such information I immediately informed the matter to IC of the PS and as per his direction I along with C/-1151 Somnath Jana, C/-698 Sasadhar Mahato and C/-924 Santosh Mahato all of Joypur PS left Kathaltard area to work out the information. At 15:00 hrs while we reached near Joritard-Agharpur village road near pond and found one Motor Cycle was coming from Joritard side. I immediately got down from our Govt. Vehicle and intercepted the above noted Motor Cycle and person, who was driving the same. On careful observation I noticed the registration no of the Motor Cycle is matched as per information. I searched the Motor Cycle and the person thoroughly and physically and on search found the above noted ID liquor (CHOLAI) loaded in a tube and thereafter in a plastic bag. On demand he failed to produce any license / authority of the said liquor. He also failed to produce any paper in respect of the Motor Cycle as well as driving license. On interrogation he also made incoherent statement regarding possession of said liquor and told that he will sell the same in Agharpur-Ramamoti village side upon the villagers illegally. So, finding no any other alternative I seized the above noted articles from the possession of the accused and labeled, duly signed by the accused person & witnesses in between 15:05 hrs and 15:25 hrs in which one bottle of ID liquor i.e. one 1000 ML was kept as sample file with label. During interrogation he confessed his guilt as such I arrested him after observing all the formalities as per law issuing memo of arrest as the accused person is liable for prosecution u/s-46A (c) of the Bengal Excise Act 1909.

I therefore pray that a specific Case may kindly be started against the accused person namely Kalipada Mondal (32) S/o-Palton Mondal of Vill-Jahajpur, PS-Joypur, Dist-Purulia u/s-46A (c) of the Bengal Excise Act 1909
