In producing herewith one arrested accused person namely Suraj @ Pain Bagti (26) S/o-Sasti Bagtil of Vill-Joypur Bagti Para, PS-Joypur, Dist-Purulia, under arrest along with seized articles as per seizer list i.e. 12 (Twelve) liters Id Liquor (CHOLAI) containing in a **Jerkin** and 01 (one) liter Id Liquor (CHOLAI) in a plastic bottle as sample file and one Glamaer Motorcycle having registration No-WB56K/0275, under proper seizure with label.

I PSI Shuvankar Sarkar of Joypur PS hereby lodged a written complaint against the above noted accused person to the effect that today (08/05/17) at about 15.45 hrs during my anticrime mobile duty at Gunja, I received a credible source information that one person namely Pain Bagti of Joypur Bagtipara was proceeding towards Bagtipara side by driving one Glamor Motor Cycle having registration No-WB56K/0275 and carrying "CHOLAI" for the purpose of selling the same in Bagtipara. On receipt such information I immediately informed the matter to IC of the PS and as per his direction I along with C/-102 Joginder Singh, C/-179 Balaram Mondal and C/-633 Dasarath Singh Mura all of Joypur PS left to work out the information. At 16:05 hrs while we reached near Block More and found one Motor Cycle was coming from Khedetard side. I immediately got down from our Govt. Vehicle and intercepted the above noted Motor Cycle and person, who was driving the same. On careful observation I noticed the registration no of the Motor Cycle is matched as per information. I searched the Motor Cycle and the person thoroughly and physically and on search found the above noted ID liquor (CHOLAI) loaded in a Plastic bag hanging in said motorcycle. On demand he failed to produce any license / authority of the said liquor. He also failed to produce any paper in respect of the Motor Cycle as well as driving license. On interrogation he also made incoherent statement regarding possession of said liquor and told that he will sell the same at his village Bagtipara side upon the villagers illegally. So, finding no any other alternative I seized the above noted articles from the possession of the accused and labeled, duly singed by the accused person & witnesses in between 16:15 hrs and 16:25 hrs in which one bottle of ID liquor i.e. one 1000 ML was kept as sample file with label. During interrogation he confessed his guilt as such I arrested him after observing all the formalities as per law issuing memo of arrest as the accused person is liable for prosecution u/s-46A (c) of the Bengal Excise Act 1909.

l therefore pray that a specific Case may kindly be started against the accused person namely Suraj @ Pain Bagti (26) S/o-Sasti Bagtil of Vill-Joypur Bagti Para, PS-Joypur, Dist-Purulia u/s-46A (c) of the Bengal Excise Act 1909
