I do hereby lodge complaint empowered by enabling the electricity act-2003 subsequently electricity (Amendment) act- 2007 to the effect that Rajib Mahato was enjoying electricity unauthorized i.e bypassing of meter by the cutting of incoming service connection. Entered the premises of Rajib Mahato, Vill. Ghagra, P.S. Joypur, Dist- Purulia, having Consumer No. 2420.92565. Meter No. R0008444 and inspected his/her premises. During the inspection theft of electricity was detected i.e. by passing the energy meter i.e. U/S135(1)/(b) was detected. The details of passing the arrangement was damage installation of the incoming wire and top 2 (two) piece of wire by which electricity directly flow to his house without energy registration in WBSEDCL energy meter.

From the above by-passing system he/she uses the following electrical equipments.

- 1) Electric Bulb - 06 nos.
- 2) Electric Fan - 10 nos.
- 3) Freezer - 01 no.
- 4) Color TV - 02 nos.

Out of which I seized the following.

PVC Cable along with by pass arrangement - 4.5 ft (approx).

Seizure list was prepared at the site and accused person refuse to sign/signed. The inspection team left the premises at 12.15PM on 29/06/17. The accused person has committed an offence U/S135(1)/(b) of the electricity act-2003 subsequently electricity (Amendment) act- 2007.
