Entered the premises of Charku Garain Vill. Ropo.
P.S. Joypur Dist- Purulia, having Consumer No. 242142427 Meter No. B2357677
and inspected his/her premises. During the inspection theft of electricity was detected i.e. by passing the energy meter i.e. U/S 135(I) (b) was detected. The details of passing the arrangement was damage installation of the incoming wire and top 2 (two) piece of wire by which electricity directly flow to his house without energy registration in WBSEDCL energy meter.

From the above by-passing system he/she uses the following electrical equipments.

- ① Electric Bulb - 3 NOS
- ② Electric fan - 3 NOS
- ③ Colour TV - 1 NOS

Out of which I seized the following

- ① PVC cable along with bypass arrangement - 14 ft (Appx)
- ② Bypass arrangement - wooden Board with MCB and without assembly.

Seizure list was prepared at the site and accused person refuse to sign/signed. The inspection team left the premises at 1.05 p.m on 29/06/2017. The accused person has committed an offence U/S 135(I) (a) of the electricity act.-2003 subsequently electricity (Amendment) act.- 2007.

You are requested to take cognizance of this complaint & treat it as F.I.R. and action may be taken as per rule.
