Sub: Request for lodging F.I.R. against arrested accused persons (1) Manaranjan Mahali (22 y) S/o-Krishnapada Mahali of Vill-Dulmi, PS-Kotshila & (2) Suresh Mahali (20 y) S/o-Nibaran Mahali (3) Sadhan Mahali (26 y) S/o-Sarkar Mahali both are of Vill-Balarampur, PS-Arsha Dist-Purulia.

Sir,

With due respect I SI Abhijit Singha of Joypur PS, beg to submit before you that on 25/06/2020 at about 00:15 hrs while myself along with ASI Ramnath Gorain and force were performing surprise Naka checking duty at Rakhbar more as per order of superior vide Joypur PS GDE No-1416/20 Date-24/06/2020 & CC No-2571/20 Date-24/06/2020 and found the following persons with their Motor Cycle, was coming to Rakhbar more, without any face cover mask. Police party detained them at Rakhbar more under Joypur PS. On being asked the following persons could not able to give any satisfactory answer for their movement on road and public place at dead hour of night, where public movement restriction is going on due to lockdown. On enquire it revealed that the persons are the inhabitant of Kotshila & Arsha PS area and without any valid reason/valid pass they were moving at Rakhbar more. Lockdown is going on throughout the District of Purulia in view of Pandemic of COVID-19 outbreak. In this respect order of Govt. of India consolidated order No-40-3/2020-DM-1 (A) Date-24/03/2020 and further modified dated-25/03/2020, 27/03/2020, 02/04/2020, 03/04/2020, 10/04/2020 & 01/05/2020. And order of Govt. of West Bengal vide Order No- 177-CS/2020 dt-18.05.2020 & 218-CS/2020 dt-30.05.2020. Are in force. As such the following persons violated the order during this pandemic situation. Moreover the detained persons were refuses to comply the direction given by the Central Govt. & State Govt. to combat the severity of COVID-19 pandemic. The accused persons also tried negligently to spared infection of disease dangerous to life. Accordingly the following persons were arrested and seized 01 motor cycle from their possession on (24-25/06/2020) at midnight about 23:45 hrs to 00:05 hrs under proper seizure list duly singed by the witnesses and the accused persons, after maintaining all formalities regarding arrest and seizure & prepared arrest memos and brought them to P.S
