In producing here with arrested accused persons namely 1) Amit Kr. Mahato (24) S/o-Late Ladhu Mahato of Vill-Radhanagar, PS-Balidih, Dist-Bokaro, State-Jharkhand, 2) Sambhu Gorai @ Bankim @ Baka (23) S/o-Manu Garai of Vill-Seardah, PS-Pindrajora, Dist-Bokaro, State-Jharkhand & 3) SK Mafijuddin @ Alu Bharta (35) S/o-Late SK Amir of Katadih, PS-Jhalda, Dist-Purulia, State-West Bengal and seized articles (1) one country made pipe gun length approx 24 cm with wooden butt cover by black robber & one round live 8 mm ammunition, (2) one Bhojali length approx 45 cm with 10 cm wooden butt, (3) one iron rod, (4) One Tangi with wooden butt approx 3.5 foot in length, (5) one shord length approx 2 Ft. & (6) one wooden bar length approx 3.5 ft. lodged complain against them and 08/09 others to the effect that on 16.02.17 night at about 00.40 Hrs in course of night mobile duty with accompanied C/-581 Tanmoy Chaterjee, C/-924 Santosh Mahato C/-975 Ashok Saha Roy and HG/-120 Uday Ch. Mahato all of Joypur PS vide CC No. 564/17 dated 15/02/17 at Joypur Ranibandh Rail Gate received a credible source information that a gang of dacoits being armed with deadly weapons like fire arms assembled in jungle Western side of Joypur-Pundag Pitch Road at Sashi more and preparing themselves for committing dacoity at Joypur. This matter informed to my IC and as per kind order myself accompanied with force immediately proceeded to the anticipated place of assembly at 00.45 hrs to work out the information and reached near Kalimandir on Joypur-Pundag Road at 00:50 Hrs leaving the Police vehicle No- WB 56B/4920 and started to proceed for the anticipated place on foot. At 01.05 Hrs reached at anticipated place led on ambush being led by the source and in the moon light we noticed that 10/12 persons assembled in the left side jungle by the side of pitch road near Sashi more and those persons are whispering from which it is clear that they are preparing themselves to commit dacoity at Joypur as it could be audible from the talks of the assembled criminals. We watched them from 01.15 hrs up-to 01.30 hrs and cordoned them. Then after disclosing our identity, I commended them to surrender but they did not pay any heed and tried to flee away. We succeeded in rounding up only 03 (Three) of them at 01.35 Hrs while the rest 08/09 were able to escaped despite hot chase after them. They disclosed their identity as mentioned above. We told them we want to searched them if necessary they can search us, but they told they are not willing to search us, then after observing all formalities I searched the above noted apprehended persons and recovered one country made pipe gun, length approx 24 cm with wooden butt cover by black robber from the left side waist of SK Mafijuddin @ Alu Bharta with loaded one round live 8 mm ammunition, and one bhojali, length approx 45 cm with 10 cm wooden butt from the left side waist of accused Amit Kr. Mahato and one iron rod from accused Sambhu Gorai @ Bankim @ Baka also searched the PO with torch light and recovered (4) One Tangi with wooden butt approx 3.5 foot in length, (5) one shord length approx 2 Ft. & (6) one wooden bar length approx 3.5 ft. Then in between

01.40 hrs to 02.05 Hrs on 16.02.17 from the place of assembly of the accused persons and from the possession of the above noted apprehended persons, after observing all formalities I, seized (1) one country made pipe gun loaded with one round live 8 mm ammunition, (2) one bhojali (3) one iron rod from their possession and (4) One Tangi with wooden butt approx 3.5 foot in length, (5) one shord length approx 2 Ft. & (6) one wooden bar length approx 3.5 ft. from the PO under proper seizure list as well as label duly signed by apprehended persons and witnesses as Alamat property in c/w above case. On interrogation they confessed their guilt and they stated that they have assembled there for committing house dacoity but they could not say about the names of other co-accused persons. I am to note here that I have to conducted search & seizure in presence of Police Witnesses as because as it was dead hour of night and it was a lonely place and I got information they assembled and making preparation for committing dacoity on gun point which may be endanger of life of Public witnesses, so I restrained collecting witnesses. Under such circumstances it is reasonably believed that the above noted apprehended persons were assembled there for committing dacoity at Joypur. So, after observing all formalities I arrested them preparing arrest memo and ground of arrest duly communicated to them.

Therefore, I pray that a specific case may kindly be registered against the arrested accused persons namely 1) Amit Kr. Mahato (24) S/o-Late Ladhu Mahato of Vill-Radhanagar, PS-Balidih, Dist-Bokaro, State-Jharkhand, 2) Sambhu Gorai @ Bankim @ Baka (23) S/o-Manu Garai of Vill-Seardah, PS-Pindrajora, Dist-Bokaro, State-Jharkhand & 3) SK Mafijuddin @ Alu Bharta (35) S/o-Late SK Amir of Katadih, PS-Jhalda, Dist-Purulia, State-West Bengal along with 08/09 others under proper section of law.
