Devs to state as follows :-

1. That on 25/11/2016 at about 10 a.m. the complainant Nemai Majhi @ Nemai Mandi came before the Ld. Civil Judges (Junior Division) Purulia to attend in his case being Title Suit No. 278 of 2016 ~~in respect of the property~~ through his Lawyer, in which the complainant is the plaintiff along with his brothers, for the date fixed for hearing which has been filed against the accused persons for declaration of title and others reliefs in respect of the property situated in Mouza Choukibera, P.S.- Joypur, District- Purulia, bearing R.S. Khatian No. 228, R.S. Plot No. 765 area 19 dec, R.S. Plot No. 1175 area 5 dec. R.S. Plot No. 769 area 21 dec. which belongs to the complainant and his brothers.

2. That the complainant also filed an injunction petition in which Ld. Court has been pleased to pass an order of ad-interim injunction in the form of status-quo in respect of the property as mentioned above.

3. That the complainant has also filed an application U/S- 151 of C.P.C. to cut down the full grown paddy, in which

Ld. Court has been pleased to pass an order directing the plaintiffs/complainant to cut the paddy.

4. That on 25/11/2016 when the complainant came before the Ld. Court, taking that advantage the accused No.1 Bisweswar Mahato along with his men and agent with the instigation and convenience with the accused No.2 Guhiram Mahato and the accused No.3 Brindaban Mahato cut down the full grown paddy from property mentioned above which belongs to the complainant and took away/stolen the paddy which planted by the complainant and kept/gathered the same in the house/khamar of the accused persons.

5. That the witness No.2 Ramlal Majhi, witness No.4 Hari Majhi and the witness No.5 Debu Majhi who saw the incident resist the accused persons who were armed with lathi did not pay any heed and the accused persons were in huge numbers along with their custs and bulls.

6. That immediately the witness informed the matter to the complainant.

7. That the value of the stolen paddy is not less than Rupees eleven thousand (Rs. 11,000/-).

8. That be it mentioned here that the complainant and his brothers/the witnesses belong to the schedule tribe community.

9. That the accused persons wrongfully occupies the land, the land of the complainant and his brothers, which previously belonged to their father and they belong to scheduled ~~kixix~~ tribe community and the land mentioned above recorded in their name.
10. That the accused persons wrongfully disposed the complaint and his brothers from their property, which recorded in their name and who belongs to the scheduled ~~tribe~~ community.
11. That the accused persons give false and frivolous information to the public servant and/or the concerned Dept. against the complainant and his brothers who belong to the scheduled caste community.
12. That soon after the incident the complainant went to the Pundag Phari to lodge complaint but the officer-in-charge of that Phari refused to take any complaint and ask them to bring the copy of the order.
13. That ~~a~~ subsequently the complaint lodged before S.P. Purulia on 02/12/2016 and on 09/12/2016.
14. That the accused persons are liable to be prosecuted 447, 143 I.P.C. U/S- 379/34 I.P.C. Sec. 3(i), (iv), (v), (vii), (ix) of the scheduled Caste and Schedule Tribe (Prevention of Atrocities) Act.
15. That the accused persons criminally trespassed and unlawful assembled have committed theft/stolen away into the land of the complainant and stolen away the paddy with dishonest intention with unlawful possession over the same. ~~and Stang bangong regarding community.~~
