In producing herewith one accd. Person namely Subal Mondal (63) S/O Lt Mahabir Mandal of Sonaijuri, PS - Kashipur, District - Purulia with seizure of 1) 45 (forty-five) bottles of approx 600ml each bottles of "DILSE" 2) 05 (five) Empty bottles of "DILSE" 3) 07 (seven) pices of plastic glass 4) Cash Rs 135 (one hundred and thirty five) which were seized under proper seizure list.

I beg to submit that on 03.01.2017 in between 19.35 hrs to 19.55 hrs in course of my mobile duty, a raid was conducted in the house of Subal Mondal (63) S/O Lt Mahabir Mandal of Sonaijuri, PS - Kashipur, District - Purulia. On acting of secret source information against illegal stock and selling of liquor of the above noted anticipated place and found that the above noted person was keeping / selling 1) Liquor which was kept in his house. On demand he failed to produce any valid document in respect of keeping and selling of liquor from the house. As such he was arrested u/s 46A (c) B.E. Act and also seized 1) 45 (forty-five) bottles of approx 600ml each bottles of "DILSE" 2) 05 (five) Empty bottles of "DILSE" 3) 07 (seven) pices of plastic glass 4) Cash Rs 135 (one hundred and thirty five) which were seized under proper seizure list.

The above arrested accd. Subal Mondal (63) S/O Lt Mahabir Mandal of Sonaijuri, PS - Kashipur, District - Purulia committed offence u/s 46A (c) B.E. Act. for un authorized possession and sale liquor from his house.

Under the fact and circumstanced I therefore pray a case u/s 46A (c) B.E. Act. may kindly be started against Subal Mondal (63) S/O Lt Mahabir Mandal of Sonaijuri, PS - Kashipur, District - Purulia.
