Dear Sir,

I do hereby lodge a complaint empowered by enabling the Electricity act 2003 subsequently Electricity (Amendment) Act-2007 to the effect that Sri Nabin Bouri, S/O LT. Atul Ch. Bouri, Vill.- Daikyari, PO- PK RAJ, Dist-PURULIA has committed theft of Electricity U/S-135(1)(a) of the Electricity Act 2003,(Amendment) Act-2007.

On dated 17.02.2017 I received a secret complain over telephone that Sri Nabin Bouri, S/O LT. Atul Ch. Bouri, Vill.- Daikyari, PO- PK RAJ, Dist-PURULIA consuming electricity by means of direct hooking for from nearest LT pole of WBSEDCL though there is a permanent connection on the said house.

On the basis of said complaint at about 11.05 am. I, Sri MrinalChowdhury, Assistant Engineer & Station Manager Kashipur Customer Care Centre, WBSEDCL along with,

- 1) Sri Dipak Kr. Bhowmik, SAE, Kashipur CCC
- 3) Sri Pradip Modak, GR-1, TSH Kashipur CCC.

Entered the premises of Nabin Bouri,, and found that he is consuming electricity dishonestly by means of direct hooking from nearest LT network of WBSEDCL.

Total Load found approx 0.5 KW (PUMP-1, bulb-1 no fan-1 no)

Then we disconnect his hooking line along with his permanent connection and seized the following articles.

- 1) hooking device arrangement with hooking wire 20 ft (approx.)
- 2) Bulb with holder---1no

After preparation of proper seizure list The seizure list are prepared at the site and the representative of accused person refuse to sign in the seizer list. The inspection team left the above premises at about 11.35 am. The accused person has committed an offence U/S-135(i)(a) of the Electricity (Amendment) Act-2007 for illegal theft of electricity.

You are requested to take cognizance of the complaint and treat it as F.I.R and action may be taken as per rule.
