

In producing here with one arrested accd namely Ajit Bauri (54), S/O- Lt Bholu Bauri of village Rampur, PS- Kashipur, Dist- Purulia along with following seized articles viz-

- 1) 20 Liters(Approx) of country spirit contained in a plastic container
- 2) 200 grams (Approx) NISHADAL,
- 3) Five pieces of glass &
- 4) Sale proceed of Rs. 155/--

I ASI Ananda Mandal of Kashipur P.S. do here by lodged a complaint against accd. namely Ajit Bauri (54), S/O- Lt Bholu Bauri of village Rampur, PS- Kashipur, Dist- Purulia to the effect that today (08.03.17) at about 18.45 hrs in course of mobile duty I received a telephonic information from a reliable source that accd. Ajit Bauri (54), S/O- Lt Bholu Bauri of village Rampur, PS- Kashipur. Dist- Purulia stocked country spirit illegally at his house at Rampur and selling the same to hike price for his personal gain. I informed the matter to O/C Kashipur PS and as per order of O/C Kashipur PS myself along with JC/1187 Samaresh Shit and NVF/1028 Rajesh Mahato both of Kashipur PS rushed to the spot for raid by Govt vehicle. At about 19.55 hrs myself along with force reached at Rampur and held raid in the house of Ajit Bauri (54), S/O- Lt Bholu Bauri of village Rampur, PS- Kashipur, Dist- Purulia and found that Ajit Bauri was mixing the country spirit, contained in plastic Container, with some intoxicated substance(like white powder)having acrid smell which is likely to cause disability or death to human being, at his own house at Rampur and seeing the police party some person fled away but police party anyhow managed to apprehend accd Ajit Bauri, and detained him. I asked him about the white powder like substance and accordingly, detained Ajit Bauri recognized it as "NISHADAL" (approx200 gms contained in a plastic) an intoxicated substance having acrid smell which is likely to cause disability or death to human being. So I arrested the above mentioned accused person informing the ground of arrest and seized the above mentioned articles after preparing proper seizure list duly sign by accd person and available witnesses and also sealed and labeled the same.

Hence I therefore pray that a specific case may kindly be started under proper section of law against arrested accd. Ajit Bauri (54), S/O- Lt Bholu Bauri of village Rampur, PS-Kashipur, Dist-Purulia and arrange for its investigation.
