Sir,

In forwarding herewith one arrested accused person namely Sadhu @Sudhangsu Sardar(56),s/o-Lt Malindra Sardar of vill-Ahattore, PS-Kashipur, Dist-Purulia before your kind honour along with all connected papers through the Police escort party after medically checked up at Hospital, I would like to note here that on 07.06.2020 at 16.15 hrs received a written complaint of ASI Giridhari Roy of this PS to the effect that at on 07.06.2020 at 14.25 hrs. acting on a secret source information ASI Giridhari Roy and force held raid at Ita vata Bheribagan of Ahattore village under Kashipur PS and found the above noted person was carrying ID liquor illegally & clandestinely in a motor cycle for selling to make profit without valid license or authority at Ita-vata Bheribagan of Ahattore village under Kashipur PS. Accordingly he seized (1) Twenty (20) liters ID liquor contained in two white plastic jarkins (2) One motor cycle having no-WB82/9134 Passion Pro (3) Two Plastic Bag. He also arrested the said accused at Ita-vata Bheribagan of Ahattore village as he committed an offence punishable u/s 46 (A)(c) of The Bengal Excise Act. Hence on returned to PS he lodged complaint and over this started Kashipur PS Case No-30/2020 Dtd-07.06.2020 u/s 46 (A)(c) of The Bengal Excise Act 1909. As per endorsement by O/C of this PS I ASI Joydev Atta took up its investigation.

During investigation I examined the complainant and other witnesses, recorded their statement u/s161 CrPC in separate sheet of papers. Then I along with force and the complainant left PS for Ita-vata
Bheribagan of Ahattore village under Kashipur PS. After arrival at Ita-vata Bheribagan of Ahattore village
under Kashipur PS.I visited the PO as shown & identified by the complainant .I searched the PO carefully
but found nothing there. I prepared the rough sketch map of the P.O. with index, examined the available
witnesses, recorded their statement u/s-161 Cr PC in separate sheet of paper. During investigation it is
learnt from the local witnesses that he was running such illegal business for a long time. During
investigation it appears that the accused Sadhu @Sudhangsu Sardar(56),s/o-Lt Malindra Sardar of villAhattore, PS-Kashipur, Dist-Purulia PS is strongly transpired in this case.

Therefore, I pray before you that arrested accused person namely Sadhu @Sudhangsu Sardar(56),s/o-Lt Malindra Sardar of vill-Ahattore, PS-Kashipur, Dist-Purulia PS may kindly be taken in judicial custody. If he released on bail there is every chance to temper the investigation and a necessary order may kindly be passed to hand over this case to O/C Excise Kashipur Circle for its further investigation.
