Dear Sir,

I do hereby lodge a complaint empowered by enabling the Electricity act 2003 subsequently Electricity (Amendment) Act-2007 to the effect that Sri Paresh Ch Mandal, S/O LT. Sudhir Mandal, Vill.- Jambad, PO- Hadalda, Dist-PURULIA has committed theft of Electricity U/S-135(1)(a)(b) of the Electricity Act 2003,(Amendment) Act-2007.

On dated 14.03.2017 I received a secret complain over telephone that Sri Paresh Ch Mandal, S/O LT. Sudhir Mandal, Vill.- Jambad, PO-Hadalda, Dist-PURULIA consuming electricity by means of tapping by with bypassing meter and by broken of terminal seal of WBSEDCL. Meter No R0086598, make Bentec Electrical and Electronics Pvt Ltd with FR 07810.

On the basis of said complaint at about 03.05 pm. I, Sri MrinalChowdhury, Assistant Engineer & Station Manager Kashipur Customer Care Centre, WBSEDCL along with,

- 1) Sri Dipak Kr. Bhowmik, SAE, Kashipur CCC
- 3) Sri Sanjoy Garain, OE Kashipur CCC.

Entered the premises of Paresh Ch Mandal,, and found that he is consuming electricity dishonestly by means of tapping by with bypassing meter in the name of Satish Ch Mandal Con Id 242100702.

Total Load found approx 1.5 KW (PUMP-1, bulb-2no fan-8 no, TV-2 no, CFL-10 no)

Then we disconnect his permanent connection and seized the following articles.

- 1) Energy Meter - Meter No R0086598 make Bentec Electrical and Electronics Pvt Ltd with FR 07810.
- 2) Bulb with holder---1no

After preparation of proper seizure list The seizure list are prepared at the site and the representative of accused person refuse to sign in the seizer list. The inspection team left the above premises at about 03.35 pm. The accused person has committed an offence U/S-135(i)(a)(b) of the Electricity (Amendment) Act-2007 for illegal theft of electricity.

You are requested to take cognizance of the complaint and treat it as F.I.R and action may be taken as per rule.
