Respected Sir,

In producing herewith arrested accused namely Binod Mandi (50), S/O - Lt Mangal Mandi of village - Sonaijuri, PS- Kashipur, Dist- Purulia along with seized articles, I beg to report that on 21.03.17 in course of mobile duty myself along with force got reliable source information that one person is selling country liquor at village Sonaijuri in his house. Accordingly myself along with C/118-Dwijapada Mahato and C/1287- Om Prakash Sharma both of Kashipur P.S reached at Sonaijuri village at about 20:15 hrs and found that one person was selling C.S.liquor in hishouse. After seeing police party liquor customers fled away from the spot. On demand the seller failed to produce any valid document for selling C.S. liquor in his possession. So the above noted accused has committed an offence U/S -46(A)(c) B.E. Act 1909 Amended up-to date. During search I found (1) 19 (Nineteen) sealed bottles of DILKHUSH C.S. liquor (600 ml each) (2) 05(Five) empty bottles of DILKHUSH C.S.(3) 05(Five) Plastic Tea Glass (4) Rs.110/- (One hundred Ten) as sale proceed seized the above noted articles under proper seizure list duly signed by the witnesses in between 20:15 hrs. to 20:35 hrs. I also seized and labeled bottles with sample C.S. liquor at the spot in presence of accused person and witnesses. Accordingly I arrested the above noted accused person U/S - 67 Bengal Excise Act 1909 and informing him the ground of arrest and I prepared arrest memo after maintaining all arresting rule as well as I brought him to P.S. with seized above noted articles.

Therefore I pray before you that kindly arrange to start a specific case under proper section of law U/S 46(A)(c) B.E. Act 1909 against arrested accused Binod Mandi (50), S/O - Lt Mangal Mandi of village Sonaijuri, PS- Kashipur, Dist- Purulia and arrange for its investigation.
