In producing here with one arrested accd namely one Dinu Mandal (52) S/O- Lt Madan Mohan Mandal of village Pabrapahari, PS- Kashipur, Dist- Purulia along with following seized articles viz-

- 1) 20 Liters(Approx) of country spirit contained in a plastic container
- 2) 150 grams (Approx) NISHADAL.
- 3) Five pieces of glass &
- 4) Sale proceed of Rs. 130/--

I SI Abhihit Singha of Kashipur P.S. do here by lodged a complaint against accd. namely Dinu Mandal (52) S/O- Lt Madan Mohan Mandal of village Pabrapahari, PS- Kashipur, Dist- Purulia to the effect that today (02.04.17) at about 18.45 hrs in course of mobile duty I received a telephonic information from a reliable source that accd. Dinu Mandal (52) S/O- Lt Madan Mohan Mandal of village Pabrapahari, PS- Kashipur, Dist- Purulia stocked country spirit illegally at his house at Pabrapahari and selling the same to hike price for his personal gain. I informed the matter to O/C Kashipur PS and as per order of O/C Kashipur PS myself along with JC/977 Tarun Kadam and NVF/1050 Rajib Saren both of Kashipur PS rushed to the spot for holding raid by Govt vehicle. At about 19.25 hrs myself along with force reached at Pabrapahari and held raid in the house of Dinu Mandal (52) S/O- Lt Madan Mohan Mandal of village Pabrapahari, PS- Kashipur, Dist- Purulia and found that Dinu Mandal was mixing the country spirit, contained in plastic Container, with some intoxicated substance(like white powder)having acrid smell which is likely to cause disability or death to human being, at his own house at Pabrapahari and seeing the police party liquor customer fled away but police party anyhow managed to apprehend accd Dinu Mandal, and detained him. I asked him about the white powder like substance and accordingly, detained Dinu Mandal recognized it as "NISHADAL" (approx. 150 gms contained in a plastic) an intoxicated substance having acrid smell which is likely to cause disability or death to human being. So I arrested the above mentioned accused person informing the ground of arrest and seized the above mentioned articles after preparing proper seizure list duly sign by accd person and available witnesses and also sealed and labeled the same.

Hence I therefore pray that a specific case may kindly be started under proper section of law against arrested accd. Dinu Mandal (52) S/O- Lt Madan Mohan Mandal of village Pabrapahari, PS- Kashipur, Dist- Purulia and arrange for its investigation.
