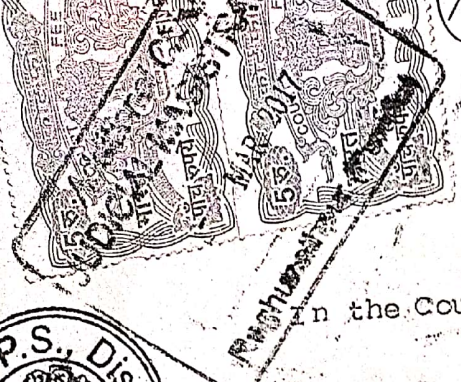

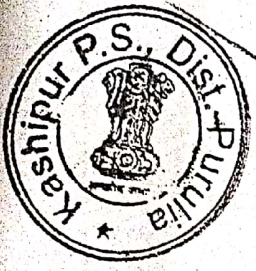

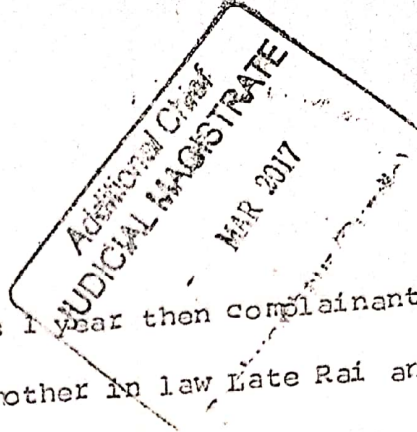

9.) That all the member of my husband house say "gives the complainant two times mealady she will will ultimately will die

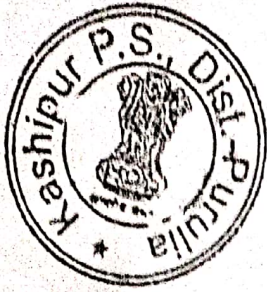
