1 ... That the Complainant is the owner & possessor of the property described in Schedule below and the complainant has been in possession by growing & harvesting paddy & other crops therein.

2... That the Complainant has acquired/inherited the property on the death of his father Rasu Mahato & R.S. record of right has been prepared in the name of Rasu Mahato.

3... That prior to the complaint his father Rasu used to grow paddy in the paddy land peacefully.

4... That like previous years this year also the complainant as usual transplanted paddy in the schedule land.

5 ... That on the occurrence i.e. on 6.12.16 & 7.12.16. at about 7 a.m. the accused persons by forming & unlawful

assembly with a view to wrongful gain & cause loss to the Complainant's property illegally & criminally trespassed R.S. Plot No. 1004, 1005, 1040, 1038 & 1035 of Mouza Kesya with Da, Sickle, axe & other weapons & began to cut the standing paddy grown by the complainant. On the 1st day the accused persons cut paddy from some of the plots & took the same with the help of curts which they carried on the following date i.e. on 21st Aghrayan the said persons again criminally trespassed & began to cut the remaining paddy grown by the complainant & took the same with the help of curts & one tractor .

6....That the complainant submits there were some other unknown persons with accused persons at the time of cutting & rubbing of paddy.

7...That when the accused persons began to cut & remove the paddy the complainant & his wife Habi bala & his witnesses raise protest but they were threaten with dire consequences & the accuseds tried to assault them.

8...That the paddy which were cut and remove from the land by the accused persons were transplanted by the complainant.

9...That the complainant has sustain a loss of Rs. 15,000/- (Rupees Fifteen thousand) due to cut & remove the paddy .

10...That the complainant is a poor man and the said paddy which were grown by him was the bread & butter of the complainant but due to overacts on the part of the accused persons the complainant has been mentally shocked.

11...That the complainant lodged complain before Kenda P.S. & the complainant thereafter lodged complain before S.P. Purulia on 12.12.16.

12...That the accused persons still remaining in the Village & they are criminally intimidating the Complainant & his witness.

13...That the accused persons have committed an offence of criminal trespass, mischief, stilling & other offences as provided U/S 427, 447, 379 506, 34 I.P.C.

It is therefore prayed that your Honour would be pleased to send the petition of complainant to the O.C. Kenda P.S. for investigating by treating the same as F.I.R.
