

The above name complainant begs to state as follows:

- That the complainant is the permanent resident of villageresident of Dumurbaid P.S. Kenda, Dist-Puruha, one Bhabani Mahato is the daughter of the complainant.
- 2) That the said Bhabani Mahato was given in marriage with the accused no-1 with Balaram Mahato on 04/01/2010 and in the said wedlock one daughter namely Riya Mahato was born.
- 3) That at the time of marriage though the complainant given sufficient cash and kinds to the Balaram Mahato in-spite of that they demanded more dowry and when it was not fulfilled the accused persons was subjected to physical as well as mental torture and she was not provided proper food and clothing and ultimately she was driven her out from her matrimonial house.
- That since thereafter, the said Bhabani Mahato was staying in the house of the complainant with her minor daughter, then thereafter the aid Bhabani Mahato filed three cases against her husband and other in-laws under section 498A/323/34, another 125 Cr. P.C. and one 494 I.P.C. against Balaram Mahato and other and those cases are more before the Let Court of law for disposal.

- That when the said Bhabani Mahato used to attended her cases the said Bhabani Mahato and his inmates off and on threatened her and also gave out that they would finish her life at an earliest opportunity.
- with criminal conspiracy on 30/11/2016 made a plan to murder the said Bhabani Mahato and on that score the accused Swapan Mahato who had taken a very handsome money from Balaram Mahato for help them in the crime called Bhabani Mahato over Mobile/ cell phone.

It may be mentioned here that for committing the crime the accused Swapan Mahato intentionally acquainted himself with the said Bhabani Mahto and for that when the said Swapan Mahato called her then Bhabani left her house with the said accused Swapan Mahato.

7) That since 30/11/2016 when the said Bhaani Mahto did not returned back then the complainant searched the said Bhabani in all the probable places including the house of the relations and when Bhabani was not be traced at that time the complainant lodged one missing diary before the O/C Kenda P.S.

- Force reported the complainant that the dead body of his said daughter was found in a jungle which was recovered by the police and sent to Purulia Deben Mahato Sadar Hospital for post mortem examination and accordingly the complainant pursuing such informant went to Purulia Deben Mahato Sadar Hospital and indentified the dead body to be the daughter of Bhabani Mahato and at the same time the complainant noticed that some injuries upon her person.
- Swapan Mahato under the direction and instruction of accused nos. 1 & 2 called Bhabani Mahato and thereafter the said Bhaani Mahato kidnapped and abetment and thereafter they have murder and the aid Bhabani Mahato in a jungle and also hanged the dead body in the tree so that anybody including the Police would take that Bhabani has committed suicide.
- 10) That for the above circumstances it is very much clear that all the three accused person with criminal conspiracy have kidnapped / abated Bhabanit Mahato and thereafter murder her and hanged her dead body in the tree.

It is also may be happen that due to inhuman pressure including threatening and inflected by the accused persons continuously upon the said Bhabani Mahto and due to such persistent torture and abatement by the accused person Bhabani perhaps committed suicide

- That all the accused persons are responsible for the death of said Bhabani Mahato and accordingly all the accused person are deserved to be punished under the law.
- 12) That the complainant thereafter lodged one complaint to the local P.S in writing and when no legal action was taken by the said Police then another complaint was lodged to the Superintendent of Police Purulia but same fate. Hence the complainant is under compelling circumstance filed this complaint before this Ld. Court under the law.

In the circumstances it is therefore, prayed that your honour may be pleased to send the petition of complaint to the Officer-in-charge, Kenda P.S. treating the same as FIR under section 156(3) for investigation.
