Dear Sir,

I do hereby lodge a complaint empowered by enabling the Electricity act 2003 subsequently Electricity (Amendment) Act 2007 to the effect that Brijaspati Mahato S/O LATE SUKI MAHATO of Village Simultand, P.O. Simultand, P.S. Kenda, Dist - Purulia, has committed theft of Electricity U/S 135(1)(b) of the Electricity (Amendment) Act 2007, having meter no. H511713 & Id no. - 242000458

On dated 24/01/17 at about 2:20PM I, Sri Bijan Guani, Station Manager, Manbazar Customer Care Centre, WBSEDCL along with,

- 1) Bikram Tudu SAE(B) Manbazar CCC
- 2) Sankar Chandra Mahato, L.M. Purulia Region
- 3) Somenath Laha LM, Manbazar CCC
- 4) Amarananda Mahato, Grol TSH, Purulia Region

entered the premises of Brijaspati Mahato, S/O Late Suki Mahato of Village- Simultand, P.O. Simultand, P.S. Kenda, Dist - Purulia and inspected his/her premises and found that he was enjoying electricity unauthorizedly tampering the meter through bypass cable from meter incoming to main switch.

During inspection, theft of electricity was found, i.e., he/she was using electricity dishonestly U/S 135(1)(b) was detected. It was also found that he/she was using the following electrical equipments -

- 1) Bulb - 3nos (3X100W)
- 2) ceiling Fan - 2nos (2X60W)
- 3) TV - 1no - (1X80W)
- 4) Table Fan 1no (1X80W)

out of which we seized the following -

- 1) APPROX 3ft. pvc wire (2 nos) in white/black colour [Bypass Portion from meter]
- 2) Bulb (100Wt) with holder
- 3) wooden board with 3 pin (1no) plug & one switch ~~board~~ and indicator

The seizure list is prepared at the site and the accused person refused to sign in the seizure list. The inspection team left the above premises at about 2:45PM on dated 24/01/17. The accused person has committed an offence U/S 135(1)(b) of the Electricity (Amendment) Act-2007.

You are requested to take cognizance of the complaint and treat it as F.I.R. and action may be taken as per rule.
