Dear Sir,

I do hereby lodge a complaint empowered by enabling the Electricity act 2003 subsequently Electricity (Amendment) Act-2007 to the effect that Brihaspati Mahato S/O- LATE SUKU MAHATO of Village- Simultard, P.O- Simultard, P.S.- Kenda, Dist - Purulia, has committed theft of Electricity U/S 135(1)(b) of the Electricity (Amendment) Act-2007, having meter no. HS11713 & Id no. - 242000458

On dated 24.01.17 at about 2:20PM I, Sri Bijan Suari, Station Manager, Manbazar Customer Care Centre, WBSEDCL along with,

- 1) Bikram Tudu SAE(A) Manbazar CCC
- 2) Sankar Chandra Mahato, L.M., Purulia Region
- 3) Somenath Laha LM, Manbazar CCC
- 4) Amarananda Mahato, Gr-I TSH, Purulia Region

entered the premises of Brihaspati Mahato, S/O- Late Suku Mahato of Village- Simultard, P.O- Simultard, P.S.- Kenda, Dist - Purulia and inspected his/~~her~~ premises and found that he was enjoying electricity unauthorised by tampering the meter through by pass cable from meter incoming to main switch.

During inspection, theft of electricity was found, i.e., he/she was using electricity dishonestly U/S 135(1)(b) was detected. It was also found that he/she was using the following electrical equipments -

- 1) Bulb - 3 nos (3X100W)
- 2) ceiling fan - 2 nos (2X60W)
- 3) TV - 1 nos - (1X80W)
- 4) Table fan 1 no (1X80W)

out of which we seized the following -

- 1) APPROX 3ft. pvc wire (2 nos) in white/black colour [By pass portion from meter]
- 2) Bulb (100Wt) with holder
- 3) wooden board with 3 pin (1 no.) plug & one switch board and indicator

The seizure list is prepared at the site and the accused person refused to sign in the seizure list. The inspection team left the above premises at about 2:45PM on dated 24.01.17. The accused person has committed an offence U/S 135(1)(b) of the Electricity (Amendment) Act-2007.

You are requested to take cognizance of the complaint and treat it as F.I.R. and action may be taken as per rule.
