I Srimoti Malati Mahato, wife of Rameswar Mahato, aged about 55 years, resident at village -Rajakhanda, P.O. - Pundru, P.S. - Kenda, Dist. - Purulia, do hereby bring to your kind knowledge that the incident of unprovoked attack on my husband and on self by Dilip Mahato, son of Late Molindo Mahato, resident at village - Rajakhanda, P.O. - Pundru, P.S. - Kenda, Dist. - Purulia for initiating a specific case.

Today at about 7.00 am, I accompanied my husband at about 7.00 am to our paddy land at near Kulugoriya pond area in Mouza - Rajakhanda, J.L. No. 07 for arranging water outlet by fixing polythene pipe. At that time accused Dilip Mahato in an adamant mood arrived at the spot and also criminally trespassed our said paddy land and started abusing both of us with dire consequences. As my husband raised mild protest, the accused became furious and pounded on my husband (65 years) and started assaulting him random fists and blows. As I tried to intervened, the accused filthily abused me and pushed me resulting my fall on the ground.

At that time in a desperate bid attempted to throatily my husband with the intension to suffocate him and thereby to put an end to his life.

It is also to mention that due to the hullah and scream raised by me, daughter of my devar Jyotsna Mahato, daughter of Panchanan Mahato and son of my bhasur, Subhas Chandra Mahato, son of Kalipada Mahato arrived there followed by others.

Information about the incident was sent to my sons at Purulia Town, who arrived at the spot immediately and at that time civic police also arrived there.

My sons arranged our removal to Chakaltor Phc and later to Sadar Hospital, Purulia.

The accused has committed various penal offences including attempt to caused culpable homicide. Hope you will take proper steps after registering a specific case.
