Charan Paul & (ii) Uttam Paul (M-28), S/o- Buddeswar Paul both of Vill- Kenda, PS- Kenda, Dist- Purulia to the effect that today on 28/06/2020, as per direction while I along with C/897 Umapada Dhalla and JC/1412 Satrugna Hansda all are of Kenda PS engaged in special mobile duty at Kenda PS area for implementation of Government rules regarding Lockdown Disaster Management Plan. While we reached at Kenda village at about 18.15 hrs. found that the above noted persons moving here and there without wearing of mask during this pandemic situation and not maintaining the social distancing.

So, there is every possibility that the above noted accused persons moving here and there without wearing a mask which violates the compliance of norms of wearing of mask during this pandemic situation and committed negligent act likely to spread infection of disease dangerous to human life and violated Government rule.

Therefore, I pray a specific case may kindly be started against (i) Buddeswar Paul (M-55), S/o- Lt. Charan Paul & (ii) Uttam Paul (M-28), S/o- Buddeswar Paul both of Vill- Kenda, PS- Kenda, Dist- Purulia as per proper section of law.
