Sub: Request for lodging FIR against arrested accused persons.

Sir,

In producing herewith 03 (three) arrested accused persons namely (i) Sadananda Mahato (32 Yrs), S/o- Pasupati Mahato (ii) Bangsi Paramanik (36 Yrs.), S/o- Lt. Bhim Paramanik & (iii) Dipak Mahato (32 Yrs.), S/o- Banku Bihari Mahato all of Vill- Raghudih, PS- Kenda, Dist- Purulia along with seizure Motor Cycle, Seizure List, Memo of Arrest, Inspection Memo & other relevant papers.

I beg to state that today (i.e. 21/06/2020), I was directed to perform vehicle checking duty under Kenda PS area. This refers to Kenda PS GDE No. 626 dtd. 21/06/2020. Accordingly, I along with force started to vehicle checking at Kenda Thana More and during vehicle checking duty at about 11:15 hrs. found 01 (one) Motor Cycle was coming dangerously from Manbazar side with 03 (three) persons in one Motor Cycle without using headgear and reached in front of Kenda Thana More. We stopped them with proper signal and asked their identity as well as to produce valid documents in respect of their Motor Cycle having Reg. No. WB56B-2138. But they failed to produce valid documents in respect of said Motor Cycle.

They disclosed their identity noted above but cannot give satisfactory answer about their such type of activities and running motor cycle dangerously with three persons in one motor cycle having Reg. No. WB56B-2138 and without using headgear. They also failed to give satisfactory answer for their such type of movement in indiscipline manner. They disobeyed to order duly promulgated by Govt. through public servants and through media etc. for prevention of attack from Corona virus/Covid-19. They are creating annoyance to the society & violated Govt. order. I arrested them after maintain all rules of arrest, issued Memo of Arrest & Inspection Memo. Informed them & their relatives regarding the ground of arrest. I seized one red colour Yamaha Crux Motor Cycle having Reg. No. WB56B-2138, Chassis No. 01C5KA024502 & Engine No. 5KA024602 running by (i) Sadananda Mahato (32 Yrs), S/o- Pasupati Mahato (ii) Bangsi Paramanik (36 Yrs.), S/o- Lt. Bhim Paramanik & (iii) Dipak Mahato (32 Yrs.), S/o- Banku Bihari Mahato all of Vill- Raghudih, PS- Kenda, Dist- Purulia with proper seizure list duly signed by the witnesses. The people left the place and did not agree to come forward to remain present in the seizure process.

After that myself arrange for medical treatment of said arrested accused persons and arrived at PS and on arrival at PS, I arrange to type this letter of complaint at our PS computer and submitted to O.C Kenda PS through duty officer ASI Tanmoy Chatterjee for taking necessary action as per law. I handed over all relevant papers, seizure list, seizure motor cycle, memo of arrest & Inspection Memo.
