In producing herewith the one arrested accused persons namely 1. Pradip @ Lakhn Kumar (27), S/o- Bibhuti Kumar of Kumardih, PO- Thakursima, PS- Arsha, Dist.- Purulia, driver of tractor, Make- Mahindra Company, bearing registration no. WB- 55A/5050 and Engine No. SR1007206802B11K02A, Chassis no- 006511260B1DS390, fitted with trolley without number plate and loaded with sand approx 105 Cft. in the trolley of the tractor, I.S.I. Banshidhar Mukherjee of Kotshila P.S. lodged a written complaint to the effect that today (on 9/1/16) at around 09:15 hrs., in course of my Night- mobile duty near Bagudi Village area, I found the above noted tractors loaded with sand were proceeding towards Ranchi Raod, Goyaladih, Kotshila from Bagudi side. I stopped the tractors at Bagudi village Road near Kotshila Girls School with a view to verify the documents but the drivers of the said tractors failed to produce any documents against the respective vehicles, their driving licence as well as the loaded sand and to carry the same in their tractors. On interrogation they confessed that, they <sup>he say</sup> procured the loaded sand from illegal quarry (Khadan), situated at Kangsaboti River Ghat near Bagudi Village under the direction of and in connivance with Dharanidhar Mahato, S/O- Bhim Ch. Mahato of Chatambari, P.S- Kotshila, Dist- Purulia, who is care taker of the above tractor and brother of the owner of the tractor i.e Taranisen Mahato, S/O- Bhim Ch. Mahato, of Chatambari, P.S- Kotshila, with a view of illegal gain through black marketing. On interrogation he also stated that he is in habit to run such illegal sand business since long. So they have committed theft against quantum of sand violating West Bengal Mines and Minerals Rule 2002 in habitual manner. I therefore seized the offending tractor along with fitted trolley loaded with illegal sand under proper seizure list and arrested the above accd. Pradip @ Lakhn Kumar (27), S/o- Bibhuti Kumar of Kumardih, PO- Thakursima, PS- Arsha, Dist. Purulia at 10:15 hrs.

Hence I pray that a specific case may kindly be started that against 1. Pradip @ Lakhn Kumar (27), S/o- Bibhuti Kumar of Kumardih, PO- Thakursima, PS- Arsha, Dist.- Purulia, driver of tractor, 2. Dharanidhar Mahato, S/O- Bhim Ch. Mahato of Chatambari, P.S- Kotshila, Dist- Purulia (the care taker of Tractor) 3. Taranisen Mahato, S/O- Bhim Ch. Mahato, of Chatambari, P.S- Kotshila (The owner of Tractor) and other involved persons under proper section of law.
