- 2) That at the time of marriage as per demand of the accused persons of the complainant had to pay a cash of Rs. 1,00,000/- along with other valuable articles and ornaments the value of those are Rs. 50,000/- but the accused persons were not happy and satisfied with either cash or articles so given to the accused person.
- 3) That after marriage the complainant was taken to her matrimonial house by the accused person and started to reside there as husband and wife with the accused no. 1 along with other accused persons in the same mess and house.
- 4) That out of that we took the complainant gave birth a male child in the year 1419 B.S. and thereafter the accused person demanded Rs. 30,000/- from the complainant for making a house and as per demand of the accused persons the father of the complainant paid Rs. 25,000/- to the accused persons with a hope that the accused persons will take care of his daughter and her son namely Dhruj Kandu.
- 5) That in the year 1422 B.S. the complainant gave birth a male child whose name has given Bhuj Kandu. There after the accused persons further demanded Rs. 1,00,000/- from the complainant for setting up a business the complainant informed the incident to her father and knew that her father
