Subj: Request for start a case.

Sir,  
Respectfully I, Asg Gobinda Lohar, beg to inform you that in course of mobile duty in P.S. area I had been an information from S.I. S. P. Thariat while I was at Bominia on Purulia - Ranchi today at about 13:15 hrs. to the effect that something packed in polythene suspected to have been containing some unknown things had been found by an unknown person floating on water in an abandoned well in the Paddy field of Kamala-Kanta Kumar s/o Laxan Kumar and his brothers near Stali Centre, Mouza Durga, P.S. Kotshila, Purulia, 100 mtrs. away from and in the left side of the Purulia - Ranchi Road. (As per direction, I had been there to verify the veracity of the information. I reached there at about 13:35 hrs. I found near about 300/400 persons gathered there. I found the same as above to ensure about the what was packed in the polythene, I arranged to lift the same out of the well and verified that from 13:45 hrs. to 14:15 hrs. I found one highly decomposed dead body of unknown female being, age appearing to be around 20/30 years approx, complexion being fair, height being 5 feet approx, hair being black and long, with no wearing apparel, bearing no symptoms of marriage, having a sign of cut mark on the throat, wrapped in a black polythene and cotton wrapper with nylon rope from head to leg and still unidentified one.

I have arranged to guard the SOC including the dead body with force until further order from your end for follow up action.

Since there was a cut injury on her throat and the dead body found in the above abandoned well under highly decomposed condition it appears a case of murder committed before 8/4 days by an unknown ones under Criminal Conspiracy with a view to causing disappearance of evidence with intention of screening the offender from legal punishment.

So, I request you to start a specific case under appropriate section of law against unknown offenders.
