Lt. Tapas Dutta, OC Kotshila PS do hereby lodge complaint Suo moto to the effect that on getting information through VP Mrinal Chandra Senapati about an incident of preparation for rioting between two groups of villagers i.e., Bortolia and Begunkudor Bauri Para under Kotshila PS, I along with ASI Samanta Tantubai, C/ 516 Chandra sekhar Mahato, C/ 985 Laxan Majhi, JC/543 Achinta Madal, JC/ 779 Santanu Singha Mahapatra and 6 EFR personnel left PS for Bortolia and Begunkudor Bauri Para vide Bortolia PS GDE no – 1168 Dated- 25/1/16 at about 08:45 hrs. When we reached at Bortolia at about 09:15 hrs, we found locals of Bortolia village were rushing towards Begunkudor Bauri Para through already harvested Paddy fields with LATHI, FARSHA, TANGI (Sharp cutting weapon) and pieces of bricks. So, the police party with a view to prevent them, made an entry through Bauripara Begunkudor and found in the said Paddy field both the above groups (Bortolia groups comprising 200/250 locals moving from west to east side & Begunkudor Bauri Para Groups comprising 150/200 locals moving from east to west side) rushing towards one another with the above arms and CVF were trying to pacify and resist them with request. The Mob of the groups were using filthy languages, intimidating and provocative words against one another. When we reached in between the agitated groups and tried to control them by saying using the Govt Supplied loudhailer that they should not move further and leave the place then and there, they without paying heed to our cautionary words, the mob of said two groups started pelting stones against one another, for which act of them, one Civic Police Volunteer sustained head injury. After shifting the injured one for medical treatment through C/ 985 Laxan Majhi, we have started to rush towards the mob of both the sides in 2 groups under the command of mine and ASI S. Jantunai with a view to drive away them by lathi charge. The mob then fled away and few Lethal weapons were left there by them. After the situation being normal there, I have seized the following articles as Alamati from the Place of occurrence in between 10:45 and 11:25 hrs accordingly: (1) 5 pieces of Bricks as sample of those thrown during the rioting, (2) 3 pieces of Bamboo Lathis (3) one TANGI (Sharp cutting weapon) (4) One TANGI (Sharp cutting weapon). Since no local witnesses turned up in fear of the recent incident, I have seized those witnessed by Police. I informed my superior officers and arranged to set Police picket there. On consultation with the On-duty police personnel and C/PS and VP, I could know Accused (1) Banka Kumar @ Banku S/O Lt Sadhu (Veteran Criminal) (2) Thakurdas Kumar S/O Lt Bhiku @ Bhikambar, (3) Ambuj Kumar S/O Ajoy (4) Agnu Kumar S/O Kartik (5) Banku Kumar S/O Aghor (6) Raju Kumar S/O Gopal, all of Bortolia, PS- Kotshila (7) Satyaban Deghoria S/O Not known of Belia, PS Arsha (Close friend of Banka Kumar), (8) Shyamapada Bauri S/O Batul Bauri (9) Jawarup Bauri S/O Not known (10) Dilip Bauri S/O not known (11) Nema Bauri S/O not known all of Begunkudor BauriPara and 300/350 other accused persons of both the above villages have been involved in the said rioting case.

So I start Kotshila PS case no- 09/17 Dated- 25/1/17 U/S 147/148/149/ 323/ 325/ 506 IPC against the above named 10 accd and other 300/350 unknown accused persons as above and directed ASI Ullash Kumar Chandra to investigate and report in Final Form in due course.
