Dear Sir,

I do hereby lodge complaint empowered by enabling The Electricity Act-2003, subsequently Electricity (Amendment) Act-2007 to the effect that Sambhunath Mahato was enjoying electricity unauthorizedly i.e. hooking from nearest L.T.O.H line to paddy extraction purpose in the form of upen Bamerjee and due to this reason he has committed theft of electricity U/S 135 of The Electricity (amendment Act-2007).

From the above arrangement he/she was using the following electrical equipments

- 2. wooden Electric Board - 01 no.

A seizure list was prepared at the site and accused person refused to sign/signed.
