The humble petition on behalf of the complainant,
most respectfully begs to state as follows:-

1. That your petitioner/complainant is the socially
legal married wife of accused Goutam Goswami s/o late
Gobinda Goswami resident of Vill.Bulmi, P.O.Timangda,
P.S.Kotshila, Dist.Purulia and the marriage has been
solemnised on 11th day of Baisakh in the year 2010
(english calendar year) as per Hindu rites and customs
prevail in the community within the jurisdiction of
this Honourable court.

2. That at the time of marriage father of the
complainant compelled to give Rs.30,000/-in cash and
other ornaments, utensils amounting to Rs.30,000/-
as per demand of the husband and his maternal uncle
and aunt i.e. accused nos.1, 2 and 3 . Here be it men-
tioned that since child hood accused Goutam Goswami
residing at his maternal uncle house at village Bulmi
P.O.Timangda, under P.S.Kotshila, Dist.Purulia as his
father and mother already been died at his childhood.

3. That after marriage your petitioner went to
her husband residing place at Vill.Bulmi, P.O.Timang-
da, and residing peacefully for few days alongwith
maternal uncle in law, maternal aunt

in law and Urmila Goswami who is the maternal ~~didima~~ of accused Goutam Goswami all are residing in some mess and house.

4. That since after few days from the date of marriage the dispute cropped up due to insufficient dowry money and they demanded further dowry and when the father of the petitioner knowing his incapability to give the physical as well as mental gradually developed upon the petitioner.

5. That being helpless lady your complainant informed the matter to the Kalyan as well as Kotshila P.S. and by the intervention of the P.S. as well as Kalyan the accused Goutam Goswami had given a written assurance that he along with other members of the house will ~~stop~~ ~~stop~~ stop not torture in future and your petitioner went at village Dulmi on the hope of performing marital relationship but all in vain.

6. That after written assurance physical as well as mental torture gradually became more horible and off and on accused Goutam along with his maternal uncle and amount and ~~didima~~ pronounces that as the father of the petitioner unable to give sufficient Dowry money as such Goutam marry for the second time and each and every night Goutam used to come let the house by consuming liquor and by this he again pronounces ~~on~~ physical as well as mental torture inflicted on the petitioner jointly.

7. That lastly on 24.4.2016 all the accused persons namely Goutam Goswami, Shankar Goswami, Ananta Goswami and Urmila Goswami started physical assault upon the petitioner from noon and they torn her saree, and blows and they driven out your complainant from the house and having no other alternative your petitioner informed the matter to her father through a telephone message ~~is~~ from the villager phone and by the help of her father as well as other villagers informed the matter to the Kotshila P.S. and Bhatbandh women P.S. but till date they did not take any legal action against the accused persons.

8. That after few months when the legal action against the accused persons was not taken your petitioner informed the matter to the S.P. Purulia ^{but} all in vain.

9. That your petitioner is deserted woman residing at her father's house at village Kotlui by the mercy of the villagers and having no other alternative filed this petition in u/s.156(3) Cr.P.C. to take legal action against the accused persons.

It is therefore prayed that your honour may graciously be pleased to sent this petition of complaint before the O.C. Kotshila P.S. for treating it as P.I.R. and for investigate the matter as per provision of law.
