

To The Officer In Charge, Kotshila P.S. District – Purulia.

Respected Sir,

In producing herewith one accd. Person namely Mukunda Mahato (21) S/O Uchitlal Mahato of Basti Kotshila, P.S. – Kotshila Dist – Purulia with seizure of 31 (Thirty one) sealed bottles of 80 mg Country Spirit "RAMBO" & each Bottle contains 600 ml. each which was seized under proper seizure list.

I beg to submit that today (05.02.17) in between 17.00 hrs to 17.45 hrs a raid was conducted in the betel leaf shop (Pan Stall) of Mukunda Mahato (21) S/O Uchitlal Mahato of Basti Kotshila, P.S. – Kotshila Dist – Purulia. On acting of a secret source information against illegal stock and selling of liquor of the above noted anticipated place and found that the above noted person was keeping / selling Country Spirit which were kept in betel leaf shop (Pan Stall). On demand he failed to produced any valid documentary authority in respect of selling of liquor from the house. As such he was arrested u/s 67 B.E.Act and also seized 31 (Thirty one) scaled bottles of 80 mg. Country Spirit "RIMBO" & each Bottle contains 600 ml (31 Bottls x 600 ml=18 Ltrs. 600 ml.) which was seized under proper seizure list in, u/s 67 B.E.Act which enclosed here with. Out of 31 (Thirty one) scaled bottles one (600 ml) scaled bottle taken out as sample with scaled & labeled. During arrest the ground of arrest were duly notified issuing arrest memo u/s 50 Cr P.C. and hande a copy of the same to arrestee.

The above noted arrested accd. namely Mukunda Mahato (21) S/O Uchitlal Mahato of Basti Kotshila, P.S. – Kotshila Dist – Purulia Committed offence u/s 46 B.E. Act. 1909 for unauthorized possession and sale of country spirit from his house.

It may note here that during raid (01) C/1179 Pabirta Mandal (02) C/ 705 Jagadish Mahato accompanied me.

Under the fact and circumstanced I therefore pray a case u/s 46 B.E.Act. 1909 may kindly be started against Mukunda Mahato (21) S/O Uchitlal Mahato of Basti Kotshila, P.S. – Kotshila Dist – Purulia.
