In producing herewith one aced. Person namely Kartik Goswami (67) S/O Gour Goswami of Begunkodar, P.S. - Kotshila Dist - Purulia with 35 (Thirty five) sealed bottles of 80 UP Country Spirit "DILKUSH" & Others brand each Bottle contains 600 ml. (under proper seizure list) each which was seized under proper seizure list.

I beg to submit that today (06.03.17) in between 06.25 hrs to 07.05 hrs a raid was conducted in the Begunkodar towers Jhalda road of Begunkodar, P.S. - Kotshila Dist - Purulia . On acting of a secret source information against illegal stock and selling of liquor of the above noted anticipated place and found that the above noted person was keeping / selling Country Spirit which were kept in Gunti shop. On demand he failed to produced any valid documentary authority in respect of selling of liquor from the house. As such he was arrested u/s 67 B.E. Act and also 35 (Thirty five) sealed bottles of 80 UP Country Spirit "DILKUSH" & Others brand each Bottle contains 600 ml. ( Total 600ml x 35 bottles =21 lits) which was seized under proper seizure list, u/s 67 B.E. Act which enclosed here with. Out of 35 (Thirty five) sealed bottles one (600 ml) sealed bottle taken out as sample with sealed & labeled. During arrest the ground of arrest were duly notified issuing arrest memo u/s 50 Cr.P.C. and handed a copy of the same to arrestee.

The above noted arrested aced. - namely Kartik Goswami (67) S/O Gour Goswami of Begunkodar, P.S. - Kotshila Dist - Purulia Committed offence u/s 46 B.E. Act. 1909 for unauthorized possession and sale of country spirit from his house.

It may note here that during raid (01) C/1220 Ajit Kumar Kandu, (02) C/ 683 Rup Chand Pauria accompanied me.

Under the fact and circumstanced I therefore pray a case u/s 46 B.E. Act. 1909 may kindly be started against Kartik Goswami (67) S/O Gour Goswami of Begunkodar, P.S. - Kotshila Dist - Purulia
