In producing herewith one accd. Person namely Mihir Kumar (26) S/O- Amulya Kumar of Pagro tola Gahanudih, P.S. - Kotshila Dist - Purulia with seizure of 33 (Thirty three) sealed bottles of 80 UP Country Spirit "DILSE" & each Bottle contains 600 ml. each which was seized under proper seizure list.

I beg to submit that today (08.02.17) in between 18.05 hrs to 18.35hrs a raid was conducted in the Grocery Shop of Mihir Kumar (26) S/O- Amulya Kumar of Pagro tola Gahanudih, P.S. - Kotshila Dist - Purulia. On acting of a secret source information against illegal stock and selling of liquor of the above noted anticipated place and found that the above noted person was keeping / selling Country Spirit which were kept in Grocery Shop. On demand he failed to produced any valid documentary authority in respect of selling of liquor from the house. As such he was arrested u/s 67 B.E. Act and also seized 33 (Thirty three) sealed bottles of 80 UP Country Spirit "DILSE" & each Bottle contains 600 ml (33 Bottls x 600 ml= 19 Ltrs. 800 ml.) which was seized under proper seizure list in, u/s 67 B.E. Act which enclosed here with. Out of 33 (Thirty three) sealed bottles one (600 ml) sealed bottle taken out as sample with sealed & labeled. During arrest the ground of arrest were duly notified issuing arrest memo u/s 50 Cr.P.C. and handed a copy of the same to arrest.

The above noted arrested accd. namely Mihir Kumar (26) S/O- Amulya Kumar of Pagro tola Gahanudih, P.S. - Kotshila Dist - Purulia. Committed offence u/s 46 B.E. Act. 1909 for unauthorized possession and sale of country spirit from his house.

It may note here that during raid (01) C/1220- Ajit Kandu (02) C/ 705 Jagadish Mahato accompanied me.

Under the fact and circumstanced I therefore pray a case u/s 46 B.E. Act. 1909 may kindly be started against Mihir Kumar (26) S/O- Amulya Kumar of Pagro tola Gahanudih, P.S. - Kotshila Dist - Purulia.
