In producing below with one a/c'd. Per
Jogeswar Mahato of Rahan P.S. - Kotshila Di-
bottles of 80 UP Country Spirit "DIL KHUSE"
seized under proper seizure list.

I beg to submit that today (21.03.17) between 20.05 hrs to 20.35 hrs a raid was conducted in the Grocery Shop of Kartik Ch. Mahato (42) S/O- Late Jogeswar Mahato of Rahan P.S. - Kotshila Dist - Purulia. On acting of a secret source information against illegal stock and selling of liquor of the above noted anticipated place and found that the above noted person was keeping / selling Country Spirit which were kept in Grocery Shop. On demand he failed to produced any valid documentary authority in respect of selling of liquor from the house. As such he was arrested u/s 67 B.E. Act and also seized 42 (Forty Two) sealed bottles of 80 UP Country Spirit "DIL KHUSE" & each Bottle contains 600 ml (42 Bottles x 600 ml= 25.2 Ltr.) each of Rs 30 X 42 =Rs-1260/which was seized under proper seizure list in, u/s 67 B.E. Act which enclosed here with. Out of 42 (Forty Two) sealed bottles one (600 ml) sealed bottle taken out as sample with sealed & labeled. During arrest the ground of arrest were duly notified issuing arrest memo u/s 50 Cr.P.C. and handed a copy of the same to arrest

The above noted arrested a/c'd Name:- Kartik Ch. Mahato (42) S/O- Late Jogeswar Mahato of Rahan P.S. - Kotshila Dist - Purulia Committed offence u/s 46A(c) B.E. Act, 1909 for un-authorized possession and sale of country spirit from his house.

It may note here that during raid (01) Mr. Gobinda Lohar (02) C. 983 Laksman Ch. Majhi (03) 681 Notam Ch. Dey (4) 223 Libon K. - Mahanti accompanied me.

Under the fact and circumstance I therefore pray a case u/s 46 A(c)B.E. Act, 1909 may kindly be started against Kartik Ch. Mahato (42) S/O- Late Jogeswar Mahato of Rahan P.S. - Kotshila Dist - Purulia
