Sub: Request for lodging F.I.R. against arrested accused Ramesh Mahato & one other

Sir,

In producing here with 02 (Two) arrested accused namely 1) Ramesh Mahato(43),s/o-Nandalal Mahato of vill-Madhupur, PS-Jhalda, Dist-Purulia 2) Sahadev Nayak(57)s/o-Lt Mukhlal Nayak of vill-Chando PS-Petowar, Dist-Bokaro, A/P- vill-Madhupur, PS-Jhalda, Dist-Purulia along with Memo of Arrest and one seized motor cycle having no-JH02AA/5745.

I SI Ramu Gurung of Kotshila PS do here by lodged a complaint against above noted 02 accused persons to the effect that on 24.06.2020 at about 23:45 hrs as per direction we were engaged for spl naka checking duty at Kotshila Tali centre naka point on Kotshila Jhalda main road that found 02 persons coming from Kotshila bazaar side in a motor cycle having no-JH02AA/5745 without any mask/facial cover. We detained them. On being asked the following persons could not be able to give any satisfactory answer for that movement at this night on the road or they could not be able to give reasonable ground for this movement. So there is every reason to believe that the said two persons came out from their home and moving aimlessly or making fun. Though lockdown is going on throughout the District of Purulia in view of Pandemic of COVID-19 outbreak vide Govt. of India consolidated order No-40-3/2020-DM-1 (A) Date-24/03/2020 and further modified dated-25/03/2020, 27/03/2020, 02/04/2020, 03/04/2020, and 10/04/2020 and an order for movement of individuals remain prohibited between 09.00 PM to 05.00 AM as per order vide memo no-232-CS/2020 Dated-08.06.2020 and also order no 79-CS/2020 Dated-12.04.2020.As such the above persons violated the order during this pandemic situation duly promulgated by Govt. of West Bengal vide Order No- H & F W/120/20 dated 22.03.2020 which is extended till 30.06.2020. Therefore they disobeyed Govt. order and committed negligent act likely to spread infection of diseases dangerous to life and violated Quarantine rule. So, I seized the motor cycle as per proper seizure list in between 00.05 hrs & 00.15 hrs on 25.06.2020 and arrested the above noted 02(Two) accused persons in between 00.20 hrs & 00.25 hrs on 25.06.2020, brought them to P.S. I offered them for medical treatment but they denied.

Hence I therefore pray that a specific case may kindly be started against above mentioned persons U/S-188/34 IPC & Section 51 in the National Disaster Management Act, 2005.
