


Most respectfully begs to state:

- 1. That your petitioner is a peace loving and law-abiding citizen of India and bona-fide residents and voters' of Golamara Gram Panchayet, P.S: Purulia (Maffasil), District: Purulia. .
- 2. That the petitioner and witness No. 2 to 4 along with others are the owner/ co-sharer of a tank locally known as Moidahir (Boro Bandh) and the same is situated within Purulia (M) P.S., Mouza Golamara, J.L.No.226, R.S. Khatian No. 129, R.S Plot no: 1578.
- 3. That sometimes in the month of October/November 2015 a proposal was made by Golamara G.P for re-excavationof Moidahir (Boro Bandh) and the petitoner, witness no. 2 to 4 along with our co-sharer had expressed their no objection in writing and the proposal for the re-excavation was under the MGNREGA (100 din er Kaj) Scheme.





- 4. That as till the middle part of the January 2017, no work of re-excavation was initiated or done in respect of said tank, accordingly, sometimes in the middle of January 2017 the petitioner and his co-sharers with witness No.5, started to enquire about the scheme and from the office of the B.D.O, Purulia-2 it was told that the re-excavation work was complete and total fund of Rs. 3,00,000/- (three lakhs was exhausted for the purpose)
  - 5. That on further enquiry it has come to light, that the Re-excavation work was sanctioned by Memo No. 243/BDO/p dated 09/11/2015 and the Master Role for the scheme was 4371 and work code was 3214002006/WC/70410186039 and the total sanction amount was Rs. 3,00,000/- out of it about 2,70,000/- was purported to be given to some labours and rest 30,000/- was utilized by the supervisors according to government statistics.
  - 6. That on enquiry from the labors whose names were shown in the master role like Suchand Rajwar, Gita Rani Mahato, Mohit Kr. Mahato, (witness No. 5 to 8 and others, it also revealed that the accused persons had asked them to deposit their job card in the Panchayat office on the pretext that they will issue new job card and after few days after getting back their old job card, it transpires that some entries were made in their job card that they had received Rs.2436 for their job in respect of the aforesaid MGNREGA



project. But actually they had never been employed in that project nor

- 7. That in respect of MGNREGA scheme all the money are to be paid through bank or post Office account and in case of departure, the video-recording and other formalities are to be observed, which was not done in this case.
- 8. That the matter was informed to the BDO, Purulia-II, in writing, but the accused persons started to showing the project of pervious year (2014-15), by manipulating office records, but a report to that effect was already been submitted before the office.
- 9. That the matter was reported to BDO, Purulia-II, O.C, Purulia (M) PS but no action was taken as the accused persons are politically influential persons.
- 10. That the matter was reported to the S.P, Purulia on 29.3.17 in writing, but no action was taken.
- 11. That there is clear violation of Government rules, Defalcation of Government money, impersonation, Forgery of documents for the purpose of Cheating and there punishable to be a feet of the purpose of Cheating and there is clear violation of Government rules, Defalcation rules, Def





12. That the investigation requires seizure of volumes of documents most of which are official documents, Job-cards, Vedio-recordings, if any etc, arrest and interrogation of accused, examination of witnesses etc.

It is, therefore, prayed that your Honour may graciously be pleased to direct the police of Purulia (Mufassil) P.S to treat this petition of complaint as a F. I. R. and to cause investigation in respect of the alleged incident.
