Begs to state as follows :-

1. That the complainant and accused persons are the permanent residents of Village- Baligara, within P.S.- Purulia(M), District- Purulia and within the jurisdiction of this Court.

2. That the complainant being the owner used the Hal plot being No. 2677 and 2668 as residential house and vacant portion as khamar and within further vacant portion has/had grown bamboo trees.

3. That in the year 2000 the complainant filed Title suit No. 147/2000 before the Civil Judge Jr. Division, Purulia against Padmalochan Mahato, Indra Mahato, Jagatpati Mahato, Patik Mahato and Latik Mahato over the plot being plot No. 2677, 2668, 1546 and 1547.

4. That after hearing the Ld. Court was pleased to pass the judgement and decree that as the property is ejmal so both the parties have got equal share over the said plots.

It also be stated here that with the intervention of local people of the village decided that both the party will reside/or used to reside separately in two places and thereafter they are reside in two places separately and the complainant and his family are residing and/or possessing the R.S. Plot Nos. 2677 and 2668 and the accuseds are residing and possessing the R.S. Plot No. 1546 and 1547.

5. That the accused persons forcibly were trying to take possession of Plot No. 2677 and 2668 when the complainant along with his brother and sons raised objection but they did not pay any heed to such objection.
6. That thereafter the complainant informed at Purulia (M) P.S. being G.D.E. No. 1647 dated 30/03/2017 and 31/03/2017 but the Police Personal did not take any step against them and thereafter the accused persons forcibly cut one thousand large size bamboos within three days of the complainant which he and his family members grown the value of the same is more than Rs. 5000/- and they have taken away.
7. That while the accuseds were cutting the bamboos the complainant filed petition U/S - 144 Cr.P. Code.
8. That after receiving notice of 144 Cr.P. Code on 31/03/2017 the above named accused persons on and from 7.00 A.M. have closed the back door of the complainant by bamboo so that the complainant and his family can not

ingress and egress from their house and told them that if they come out from house they will kill them ~~life~~.

9. That they have cut and removed the bamboo about 25/30 piece 30/03/2017 thereafter other two days also have cut same number of bamboos and have removed to their house and also have blocked the back side door of the complainant by fencing by those bamboos.

10. That on next date i.e. 31/03/2017 at about 6.30 A.M. the accused persons also cut and taking away bamboo trees about 100⁺ pieces in three day value ~~of~~ ^{bamboo} of Rs. 5000/- and as on 30/03/2017 information was lodge only 30/40 bamboos have been written.

ix It also be stated that O.C. Purulia(H) P.S. did not take any steps though three days information was given orally ~~in him~~.

11. That thereafter information was given to S.P. Purulia but no case has yet been started , for which the complainant has been compelled to file this petition before this Ld. Court u/s- 156(3) Cr.P. Code as the complainant is a poor innocent person for the punishment of the accuseds for cutting and removing the bamboos of the complainant.
