I do hereby lodge my complaint empowered by the Electricity (Amendment) Act-2007 to the effect that Dibakar Bouri S/O Surja Bouri of Vill - Gobradih, PS-Purulia(M) has committed theft of electricity under section 135(1)(a) as detailed here under.

Today, i.e. on 06.06.2017 I, Prashant Kishor (AE&SM), along with Sri Chinnoy Maity, SAE(E), & Debdulal Banerjee, Sr.TSH, of Telkalpara CCC, WBSEDCL conducted a raid programme at village Gobradih under Purulia(M) P.S. When our team at about 11.40 A.M. entered to the Commercial premises of Dibakar Bouri, we found that he was enjoying electricity directly by means of direct hooking from nearest LTOH line and run Cable TV amplifier machine. WBSEDCL losses revenue. As theft of electricity was detected in presence of the local witnesses, amplifier machine dismantled, seized and seizure list prepared. The seized material labeled in presence of the local witnesses. The inspection team left the aforesaid location at about 11.10 P.M. after completion of inspection & necessary formalities.
